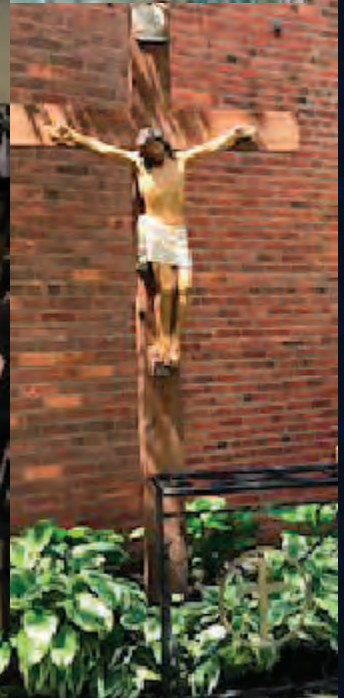


## Council #84 Summer Fling

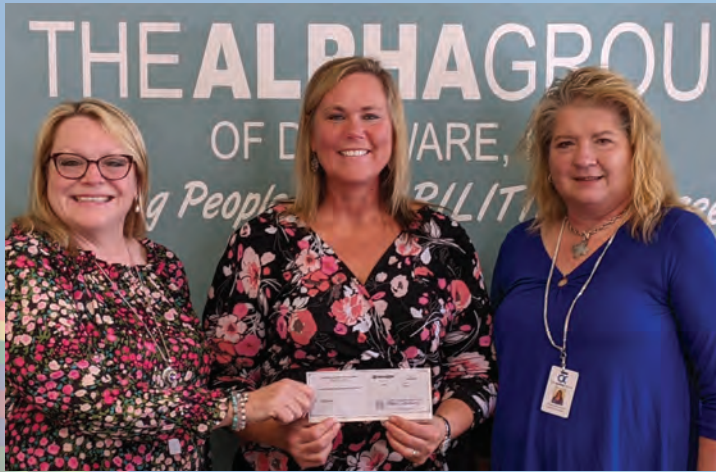

The Board voted to raise the interest rates effective June 15, 2022 on annuities, IRA's and Roth IRA's. The new rates are posted in the Index and on the CLC website. The guarantee rate of 1.5% will remain the same. The Directors along with CLC's advisors, Parkway Advisors and Allen Bailey and Associates, CLC's actuary, are constantly reviewing the changes in the economy.
