For and in consideration of the privilege of participating or engaging in shooting sports and any other social, sporting or recreation activities from time to time conducted on the premises know as Pinetucky Skeet & Trap Club Inc. a/k/a Pinetucky Gun Club in Richmond County, Georgia, for which I have paid a fee, I for myself, my heirs, executors, successors, and assigns, and all others claiming by or through me, do hereby forever fully release and discharge Pinetucky Skeet & Trap Club Inc. a/k/a Pinetucky Gun Club, and its management, membership, employees, agents, officers and board of trustees, and the Board of Commissioners of Richmond County, Georgia, their heirs, successors, and assigns, from any and all claims and demands, actions, causes of action and damages, cost, loss or services, expenses, and any and all claims whatsoever , both law and in equity, on account of or any way resulting from personal injury, conscious suffering, death, property loss or damage, or other loss or damage sustained by me or caused to me arising out of , directly or indirectly, activities, that I choose to engage in upon the premises known as Pinetucky Skeet & Trap Club Inc. a/k/a Pinetucky Gun Club or sustained by me or my guest in travel to or from the premises known as Pinetucky Skeet & Trap Club Inc. a/k/a Pinetucky Gun Club, meaning and intended to include in this release and discharge also such personal injuries , conscious suffering, death or property damage resulting from and in any way connected with shooting sports , utility vehicle riding , ATV riding, motor vehicle use, or any other activities incidental to my voluntary use and enjoyment of the facilities provided by Pinetucky Skeet & Trap Club Inc. a/k/a Pinetucky Gun Club, and its management, membership, employees, agents, officer and board of trustees, and the Board of Commissioners of Richmond County, Georgia, their heirs, successors and assigns, including but not being limited to the negligence of the said Pinetucky Skeet & Trap Club Inc. a/k/a Pinetucky Gun Club, its management membership, employees, agents, officers and board of trustees, and the Board of Commissioners of Richmond County, Georgia.

In consideration of the foregoing premises, I do hereby expressly stipulate, covenant and agree to indemnify and hold forever harmless Pinetucky Skeet & Trap Club Inc. a/k/a Pinetucky Gun Club, its management, membership, employees, agents, officers and board of trustees, and the Board of Commissioners of Richmond County, Georgia, their heirs, successors and assigns, from any and all actions and any and all other claims for damages whatsoever which may hereafter arise from my negligence or the negligence of any other person or entity, willful or wanton, or intentional acts or actions.

The terms of this release and indemnification agreement are contractual and not mere recital and contain the entire agreement between the parties hereto and shall continue in full force and effect until revoked in writing by each of the parties hereto.
