

Somerset Swim & Tennis Club

Rules and Regulations – Updated 2023

- The Club is a private club for the use of members and annual passholders and their guests only. Please see the Guest and Party Policies. **Guests must be accompanied by a member or passholder.**
- The Club Directors have the authority to enforce any and all rules pertaining to the Club and can suspend privileges of anyone violating these rules. Every member of the Club is obligated to help care for the facility and to obey all of the rules and regulations.
- Hours of Operation: 8 am to 9 pm, subject to weather or decision of the Directors. **Use of any part of the Club outside these hours subjects member or passholder to suspension of privileges.**
- **Tampering with the security cameras is reported to the Sheriff.**
- **NO LIFEGUARD ON DUTY – SWIM AT YOUR OWN RISK.**
- Children 14 and under must be accompanied by an adult at all times.
- Children 12 and under must be supervised at all times when they are in the spa, as the temperature may exceed 100° F.
- The children's pool is reserved for children ages 7 and under.
- Cost of Club property damaged or destroyed by any member or annual passholder or his/her guest will be billed to the member or annual passholder for immediate payment.
- No pets are permitted inside the fenced area.
- No smoking inside the fenced area.
- No glass containers are permitted inside the fenced area.
- No amplified music inside the fenced area. Any music must not be so loud that it can be heard outside the fence.
- The Club will not be responsible for loss or damage of personal property.
- All members and annual passholders and guests are responsible for picking up trash and disposing of it in appropriate receptacles.
- There is a \$25 replacement fee for any lost key.
- Pool furniture must not be removed from the concrete areas around the pool or in the pavilion.
- Only appropriate swim wear may be worn in the pool and spa (no cutoffs).
- Absolutely NO running, pushing, rough play, diving or unsportsman-like conduct permitted.
- Flotation devices and toys must be less than three feet in diameter.
- No bicycles, roller blades, scooters, skateboards, or motorized vehicles are permitted inside the fenced area.
