### ARE YOU PLANNING TO EXTEND?

In recent years Fieldend has become increasingly appreciated as one of the best examples of affordable modernist architecture and planning in Britain. This rising status has helped the houses become more desirable and highly valued than they once were.



Part of this value derives from a degree of uniformity in the exterior appearance of the houses. Only by maintaining that essential uniform character of Eric Lyons' original vision can this added value can be maintained or even increased. That's why, when adding or replacing extensions, a sympathetic, careful approach is required.

### WE ARE HERE TO HELP.

If you are thinking about undertaking building works that effect the appearance of your house, please first read the 'Planning' section of the Fieldend website.

The FRAL board also encourage you to get in touch with us at the earliest possible stage of your design process (preferably before you engage an architect or builder) so that we can work *with* you to achieve FRAL approval, as required by the Fieldend Scheme of Management. We can also help advise on the latest Richmond Council planning guidelines.

Once your design has the go ahead from FRAL and the Council, it is important that any pre-commencement conditions listed in your planning consent (especially regarding material and colour) are also approved prior to work starting. It's crucial your builder understands and delivers a structure in accordance with the approved design.

## GETTING READY FOR THE 2024 RE-PAINT

It may seem the last coat is barely dry but this quadrennial event will soon be upon us again.

That means it's time to take stock of the woodwork on the outside of your house!!

To this end our decorator of choice for the last 2 repaints, the mellifluous Mark Tullet, will be on Fieldend to have a close look at your boards, sills and frames from around late February/early March THIS YEAR.

Mark's mission is to assess the condition of your house's exterior woodwork and then create a bespoke survey (to be delivered a few weeks later) that will point out any areas of concern that should be repaired ASAP, before being repainted next year.

As usual Mark will quietly (?) get on with this task but will be using a ladder and need access to your back garden, so please expect a gentle knock on your door late next month.

### **WEATHERBOARD NOW IN STOCK**

We have recently taken delivery of lots of Fieldend Profile Siberian Larch Shiplap. Its a good A-Grade batch with very few knots and will be extremely durable. Inevitably the price has shot up and we must now charge £65 per 4 metre length.

While re-boarding an entire fascia looks great these boards will slot into the existing fascias, and remember - its almost always better and quicker to replace these rather than repair.





### **BOOK YOUR CARPENTER SOON**

Unfortunately it's been a tough 9 months for our painted woodwork. A very dry summer followed by a cold snap, then an endless deluge...

Extreme weather can cause older, damaged wood to shrink and swell, causing cracks in the paint which then lets water in. It's very important to identify these problems early, that's why we survey a full year before the repaint.

Fieldend's *almost* resident carpenter, Geoff Bates, has availability later in the year but there are plenty of other options out there, so once you get your survey there's no time to lose.

If you can't get the work done immediately even a simple, well-targeted coat of primer this summer could prevent further damage next winter.



## **PLUG & PAY**

IN YOUR GARAGE

With the recent sky high electricity bills it's more important than ever that residents let FRAL know if they have an appliance in their garage that is always on, or are perhaps regularly using any other power hungry devices, such as heaters, that may need to be itemised.
