- Receipts between 3/9/2021 and 4/12/2021 totaled \$ 79,385.41. [First half property taxes up approx. 4% over 2020].
- Expenses totaled \$14,691.81. Fund balances totaled \$181,902.66
- Kay made motion to accept the financial report; Jim 2nd; Scott in agreement.
- Discussion on selling the brush hog mower took place. Decision was to put it on govdeals for \$6,000.
- Township property and casualty insurance is being reviewed.

#### **NEW BUSINESS**

 Scott asked Cheryl to submit a sealed bid request for chip and seal to Melway and Sarver. Sealed bids are to be opened at the May 10<sup>th</sup> business meeting. Trustees are entertaining the thought of chipping and sealing 8-10 miles of road.

- Jim is researching the request from the home owner on 302 and 42 who wants a no-break sign. He presented what he anticipates the procedure to entail. Trustees all in agreement he should move forward with the request.
- Kay submitted a bill from resident Ross Oehling on Twp Rd 133 for replacement of his mailbox. Trustees directed Cheryl to reimburse for everything but tax.
- Trustees approved the purchase of a copier for the township house. Cheryl will purchase and install.

### **OLD BUSINESS:**

• Clips and Cuts were hired to mow. Nick Ritchey was present for Q&A. Trustees entertained questions regarding the mowing schedule and expectations for weed eating around plot decorations. Asked that driveway be sprayed regularly and both mowing & weed eating be done before Memorial Day.
