February 25, 2019

Regular Meeting called to order by Trustee Chairperson Scott Markley with the Pledge of Allegiance. Present Trustees Scott Markley, Kay Wright and Jim Power, Zoning Inspector Steve Nemec, Road Supervisor Herb Wiles, guests Kenny Howell, Robert Turk, Sarah Manek, David A. Hostetler and John Taranowski. Fiscal Officer Cheryl Welch absent from this meeting, Trustee Kay prepared minutes for this meeting.

Minutes for the February 11<sup>th</sup> meeting were approved with corrections—Jim made motion, Scott seconded.

#### Road Report:

Road supervisor Herb reported plowing snow on all roads and the logs have been removed from Twp. Rd. 53.

Herb reported cutting and removing downed trees and clearing brush from roads after unusual high winds. He, also, reported Trustee Scott helped him with this on Twp. Rds. 1080, 251, and 101.

Herb reported repairing sliding bay door. Trustee Jim was very pleased Herb repaired it correctly and did not cut corners.

Herb asks for the right to purchase a load of cold patch for Twp. Rd. 133. After a short discussion, Jim made a motion permitting Herb to purchase enough cold patch for Twp.Rd.133. Kay seconded and Scott in agreement.

#### Zoning:

Zoning Inspector Steve addressed David A. Hostetler's questions about a lot split and Trustee Jim provided him with the name of a good surveyor.

Steve reported he will be unable to work for about two weeks because of back surgery. He will be able to handle paperwork and to give verbal answers.

Trustee Kay was given the go ahead to continue with the door stick notes, requested by Steve.

Steve reported trash has been cleaned up at location on u.s.42.

Kenny Howell reported two dwellings on the same property address 1046 St.Rd.89. Kenny, also, asks about tarp shop on Co.Rd.620 east of Cinn.shops, Steve will check on both.

Jackson Township Zoning Board has held their 2019 Organizational Meeting.

### Fire Department:

Trustee Scott reported 15 fires / Squad runs 25 / Mutual Aid 7 / Public Service 1; property loss in Jackson \$6,000.00, fuel used 31 gals. gas and 185 gals diesel. This report is for January 2019 and is attached.

Park Board:

Trustee Jim had no report.

Cemetery Board:

Trustee Kay reported Herb has repaired Cemetery Sign, but has not had time to put it up. Trustee Kay feels sign looks great.

Kay will be checking on prices of drainage pipe for the cemetery.

Old Business:

Robert Turk asks if Scott has had contact with the Co. Engineer about Twp.Rd. 351. Scott reported he will be meeting with the Co. Engineer in mid-March, on the Twp.Rd. 351 issue.

John Taranowski reported on an abundance of information he had found on Bio Hazardous Waste. He has met with the Ashland Co. Farm Bureau, Wayne Co. Commissioners, Ashland Co. Emergency Management and Andrew Gall with the Ohio EPA; his information is very compelling. This compelling information is leading to the conclusion that the EPA has a very tight grip on what goes on in this state. However, it is still important to have a section in our zoning resolution on the handling of these products. John reported, he has attended several zoning work sessions and they are working on this issue. Thank you for all of your work on this issue, John.

New Business:

Trustee Scott introduced everyone at the meeting to the new used truck.

Trustee Kay talked about the Lake Erie Bill of Rights and how it might impact Jackson township. Everyone felt this bill would not pass in the special election the next day and the issue was dropped.

Trustee Scott asks if any questions on warrants or financial reports, as there were none, Trustee Jim made a motion to accept the warrants and financial reports, Trustee Kay seconded and Trustee Scott in agreement. The previously prepared checks were signed and placed in box as requested.
