

WOLF CREEK STABLES, LLC. RELEASE OF LIABILITY FROM RIDER/PARENT/GUARDIAN. THIS AGREEMENT is

between WOLF CREEK STABLES, LLC, hereinafter referred to as EQUESTRIAN CENTER and _____,

hereinafter referred to as RIDER/PARENT/GUARDIAN. For consideration received, and in return for the use, today and on all future dates of the property, facilities and services of Equestrian Center, Equestrian Center's instructors, employees and agents, Rider/Parent/Guardian, Rider/Parent/Guardian's heirs, assigns, and representatives, hereby agree as follows: 1. Inherent Risks and Assumption of Risk. The undersigned acknowledges there are inherent risks associated with equine activities such as those described below, and hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to, the propensity of equines to behave in ways such as, running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them; the unpredictability of equine's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; certain hazards such as surface and subsurface conditions; collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participant's ability. Rider/Parent/Guardian acknowledges that horses, by their very nature are unpredictable and subject to animal whim. Rider/Parent/Guardian assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising therefrom. Rider/Parent/Guardian agrees to abide by and follow Equestrian Center's rules and regulations which, shall be posted and/or made available from time to time. Rider/Parent/Guardian further acknowledges that the behavior of any animal is contingent to some extent upon the ability of Rider/Parent/Guardian. Rider/Parent/Guardian assumes all risks therefor and warrants a full and fair disclosure of Rider/Parent/Guardian's abilities has been made to Equestrian Center. Rider/Parent/Guardian expressly releases Equestrian Center and its owners, agents, employees, successors or assigns, lessors and joint venturers from any and all liability, damages claims, demands, actions and causes of action whatsoever (collectively "claims"), including but not limited to legal fees and expenses incurred by Equestrian Center in defense of such claims, both in law and equity, for personal injury, conscious suffering, death or property damage sustained by Rider/Parent/Guardian or others while using Equestrian Center facilities or participating in any of the activities conducted by Equestrian Center, even if caused by negligence (if allowed by the laws of the State of New Hampshire) by Equestrian Center or its owners, representatives, agents or employees.

Warning Under New Hampshire law, an equine professional, or any other person engaged in an equine activity, shall not be liable for an injury or the death of a participant resulting from the inherent risks of equine activities pursuant to New Hampshire Revised Statutes § 508:19 (2001). 2. RIDER/PARENT/GUARDIAN AGREES TO HOLD HARMLESS, INDEMNIFY AND DEFEND EQUESTRIAN CENTER AND ITS OWNERS, AGENTS, EMPLOYEES, SUCCESSORS OR ASSIGNS, LESSORS AND JOINT VENTURERS AGAINST ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION, DAMAGES, JUDGMENTS, ORDERS, COSTS OR EXPENSES, INCLUDING LEGAL FEES AND EXPENSES, IN BOTH LAW AND EQUITY, WHICH MAY BE INITIATED AGAINST ANY OF THE FOREGOING BY ANY PERSON ARISING FROM OR CONNECTED WITH RIDER/PARENT/GUARDIAN'S USE OF OR PRESENCE UPON THE PROPERTY OF EQUESTRIAN CENTER AND THE FACILITIES LOCATED THEREON. 3. In the event Rider/Parent/Guardian is using Rider/Parent/Guardian's own horse, or a horse(s) not owned by Equestrian Center, Rider/Parent/Guardian warrants said horse(s) shall be free from infection, contagious or transmittable diseases. Equestrian Center reserves the right to refuse access or use of any horse upon the premises that does not appear to Equestrian Center to be in good health, or is deemed dangerous or undesirable. 4. Rider/Parent/Guardian agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.
