If more RIAs and investors looked at the data, they would stop using funds, here's what you will see...

Returns

- Past performance is meaningless without big down markets included (i.e., Mar 2000-Oct 02 and Nov 07-Mar 09)
- Short-term returns are meaningless, long-term compound average annual returns (CAGR) with down markets is better
- For income, the low-risk stock portfolio with solid dividends provides more income than fixed income investment products
- For growth, each low-, mod- and high-risk stock portfolio has a higher long-term CAGR than every mutual fund\ETF sold today

Risks

- All 3 low-, mod- and high-risk stock portfolios have better risk\reward than mutual funds\ETFs
- The low-risk stock portfolio has the same potential risk of capital losses as intermediate bonds
- · The mod-risk stock portfolio has the same potential risk of capital losses as a balanced fund
- The high-risk stock portfolio has the same potential risk of capital losses as long-term bonds

Costs

- For a current vs. recommend portfolio review, Nob Hill charges a one-time fee of 0.15%, no annual fee, no other fees
- The largest bond funds average expense ratio = 0.53%; ETFs = 0.07%, does not include fund's distribution or transaction fees
- The largest stock funds average expense ratio = 0.50%; ETFs = 0.10%, does not include fund's distribution or transaction fees
- Mutual Fund\ETF transaction fees (buys\sells) are a profit center for the fund companies, this is why they promote them


Taxes (non-IRA)

- Individual stocks have lower tax rate on dividends vs. higher income tax on interest from savings accounts, CDs, and bonds
- Individual stocks have lower cap gain rate on sales > 1 year vs. higher income tax on insurance cash value and annuities
- · Individual stocks have lower stepped-up cost basis vs. higher income tax on insurance cash value and annuities

Other Factors


- Funds can own shares of companies you may not want to own (i.e., Microsoft, Google, Facebook)
- Index fund's new investor cash buys stocks regardless of valuation, thus index funds can overpay for stocks
- Fund managers wield great power by proxy voting to influence company operations on behalf of fund investors


Risk\Reward - Bond & Stock Index Fund Asset Classes vs. 3 Stock Portfolios - Last 25 Years










































