

Privacy Policy

Protecting your private information is our priority. The Statement of Privacy applies to <http://fittpalooza.com>, FITTPALOOZA, and FITTPALOOZA5K® and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to FITTPALOOZA include <http://fittpalooza.com>, FITTPALOOZA5K®, and all other subsidiary companies. Collection on Your Personal Information

In order to better provide you with products and services offered on our Site, FITTPALOOZA may collect personally identifiable information, such as your:

Use of Your Personal Information

FITTPALOOZA collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Sharing Information with Third Parties

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by FITTPALOOZA. Use of Cookies
