Treasurer report : We now have 40 paid members since March 2021 renewal. Mel Weaver paid making it 41. They claim the land planner should have something to show us the week of May $3^{\text {rd }}$. In 1958 they took over the right of way at $78^{\text {th }}$ \& Busch street per Ron, along with other county owned right of ways. Code enforcement was called on her because of another gate she built a few weeks prior on $33^{\text {rd }}$, she blames PCFTA although we believe it was Realtors trying to sell the property next to her. Charles asked Kathy to send him a survey of the property for sale. Some members rode $33^{\text {rd }}$ the day after the challenge event and the gate was open with no problems. If she closes the gate it also blocks her neighbors use of Silver Oaks way.

## New Business:
