## PCFTA Meeting Notes May 24, 2022 - Called to order 7 PM

Officer Present: Charles & Karen Rayside, Candy New, Cindy Stein, Ron Shewmaker

Karen gave membership & financial report. We have collected \$1,208 in dues and the bank account is now \$9135. We wrote checks for Trail cleaning and lunch that have not cleared yet. Karen Nominated Melanie Truman for the vacancy on the board left by Randi Sharpe, Sibyl 2<sup>nd</sup> and Candy 3<sup>rd</sup> all agreed. Karen also discussed Public Relation Events - our involvement in a successful "Kentucky Deby Day Parade" at Two local Nursing homes. Melanie Truman spearheaded the Jensen location for the first time. Both were a success. We also discussed picking up Teresa's Kids on Horseback from Citrus Grove Elementary again. The PE Coach is to take the Ride with us on horseback, and we are to use the new trail around the pond at Citrus Grove Elementary & The park.

Sibyl asked how many Members we had. Karen responded 31 paid so far this year 40 + more not paid. Time to send out paper reminders.

Trails recently cleared was discussed by Candy. The ditch crossing at Quail Hollow & Boatramp is a concern and very steep. We discussed another bridge and culvert like the one Ron and Mel built several years ago. We talked in detail with Ron, about how to get a culvert installed.

Sibyl talked about the Group Ride at Atlantic Ridge, Saturday the 28<sup>th</sup> 9 AM in the saddle. She is going to confirm with Ike about Hobe Sound Entrance, and logistics about where to park.

Karen Passed around the Tack Sale flyer from Tail Winds. Cindy & Candy agreed to man table at the event on July 10<sup>th</sup> to represent PCFTA. It was agreed we would Partner with Tail Winds, and we would receive ½ the funds collected by Tail Winds. Charles will order a Banner since we have not been able to find the old one.

Charles talked about a Commission meeting he recently attended and ran into the Land Planner for Countess Joy. That sparked an Email to Ron with a proposed settlement. Ron followed up with more details, and that he would only approve the settlement proposed by Charles last year.

Ron read a Plan for The Trail Association that he wrote. He charged all members to observe and record all ROW's that are unlawfully taken. He presented and discussed grid maps and charged members to learn and understand it. He asked that PCFTA keep a log of taken ROW's.
