## **Palmyra Township Building Permit Fees**

Adopted September 12, 2019

If work for which a permit is issued is not started within six (6) months of the date of permit issue, or if work is stopped or abandoned for a period of six (6) months, the permit shall lapse and cease to be in effect. In the event the permit shall lapse, the permitee shall pay \$75.00 to renew. NO FURTHER CONSTRUCTION SHALL TAKE PLACE UNTIL THE EXPIRED PERMIT IS RENEWED. TEMPORARY OCCUPANCY PERMITS ARE ONLY ALLOWED AFTER REVIEW AND WITH PAYMENT OF A \$150.00 NON-REFUNDABLE APPLICATION FEE. A 30 DAY EXTENSION OF A TEMPORARY OCCUPANCY PERMIT MAY BE GRANTED WITH PAYMENT OF A \$300.00 NON-REFUNDABLE APPLICATION FEE.
