6) DOUBLE EVENTS:

 Due to some circumstances where the artist has been booked on the same scheduled date by two different clients, the makeup artist will contact both clients and coordinate a suggested location for both clients to receive their makeup services at different times.
Double event circumstances DO NOT happen that often unless it is a very popular weekend which results in artist getting double booking.

7) MISCELLANEOUS:

The Wedding Agreement, if any, set forth the entire agreement between the parties, and may not be amended except in writing signed by both parties. This Project Agreement will be governed by and construed in accordance with the laws of the State of Illinois, without regard to the principles of conflicts of law. In any action or proceeding involving a dispute between the Client and the Artist arising out of this Project Agreement, the prevailing party will be entitled to receive from the losing party reasonable attorney's fees. If the Client below chooses to come to the Makeup Artist's location, the Makeup Artist signed below will NOT be responsible or liable for any physical injury due accidental fall or bump while at the location. The Makeup Artist will NOT be responsible for any allergic reactions caused by the products used. Any photos taken by the artist belong to Saleha Abbasi – Makeup Artist. Makeup Artist and Bride have each caused this Service Contract to be signed by it duly authorized representative.
