ORDINANCE NO. 2017-06

AN ORDINANCE AMENDING ORDINANCE 2015-03 VILLAGE OF GETTYSBURG'S RIGHT TO ABATE, ENFORCE, AND NOTIFY ZONING AND ORDINANCE VIOLATORS

WHEREAS, it is deemed necessary and advisable to amend the rules and regulations of ORDINANCE NO. 2015-03 AN ORDINANCE ENACTING AN EXTERIOR PROPERTY MAINTENANCE CODE FOR THE VILLAGE OF GETTYSBURG, OHIO

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Gettysburg, Ohio as follows:

- 1. Ordinance No. 2015-03 is hereby amended in the following fashion:
 - a) In the event of abatement, the Village of Gettysburg will impose a \$150.00 an hour fee for all services rendered by the Village of Gettysburg employees, with a minimum of one full hour for any fraction of the first hour, and for every hour post the first hour to be prorated to the nearest quarter hour.
 - b) The enforcement of any and all provisions of ordinance 2015-03, by authority of Zoning & Planning Chair, the Mayor, or in the Mayor's absence, the Village Council President as duly named in ordinance 2015-03, can be placed with the Fiscal Officer, Village Administrator, or any authorized Village Personnel, as they believe may be required to carry out and effectuate all of the provisions there-in ordinance 2015-03.
 - c) Where a violation of any provision of this Code is found to exist, the Fiscal Officer, Village Administrator, or any authorized Village Personnel, by Authority of the Zoning & Planning Chair, the Mayor, or in the Mayor's absence, the Village Council President, shall cause a written notice of such violation to be served upon the owner, manager, occupant, or other person responsible for the correction thereof as set forth in ordinance 2015-03.
 - d) Where an offender, having been served with notice for violations as set forth in ordinance 2015-03, shall consider initial notice a final notice covering all offenses set forth in initial notice for the year standing; otherwise will not be served with additional notices for repeat offenses, but will be subject to penalties outlined in ordinance 2015-03, and/or this ordinance 2017-06.

This Ordinance shall be effective at the earliest time permitted by law.
