Due to limited storage, your items will be held for a maximum of 5 days from the contract expiry date. After the 5 days, items will be donated to the Side Street Vintage (SSV) store inventory or, if not returned to inventory, the item(s) will be donated to a charity or non-profit outfit of our choice.

It is the full responsibility of the consignor to manage, check in and settle their accounts. Accounts and any money earned credit will expire after 1 year with no activity.

Consignors will receive 40% of the final sale price.

Payments will be issued by Etransfer or cash (pending amount) at the end of the 90-day term. You can use your earned credit at any point for in-store purchases, excluding the sale of a gift card.

SSV will price all items based on age, condition, brand, style & product demand. There is a maximum of 20 items during the 90-day term. Side Street Vintage reserves the right to return any unsold items to the consignor at any given time or in the case of a season changeover.

All clothing items must be freshly laundered, stain-free, odour-free, in excellent used condition and folded down nicely into a box or tote, labelled with your name. All shoes must be wiped down and free from soil and scuffs. SSV has the right to refuse items that are brought in without meeting these criteria.

Walmart, Giant Tiger, Old Navy, Joe Fresh, Forever 21, Ardene, Shein, Seduction, Urban Planet, and H&M will not be accepted. This list of non-accepted brands is subject to change at any point. Any items needing dry cleaning, repairs, appraisals, and third-party authentication expenses required prior to items being displayed will be billed to the consignor. Items in need of laundering will be charged to the consignor at \$2.00 per item.

Please note: It is illegal to sell counterfeit luxury goods. An authentication receipt of the certificate will be required. SSV will not knowingly buy or sell counterfeit items and will immediately return or donate items deemed counterfeit.

Side Street Vintage will be responsible for taking the necessary steps to sell your items quickly and efficiently, including in-store promoting, market price evaluations, showcasing products through social media and listing items on sale after the first month of being in-store.

Side Street Vintage will provide reasonable effort to safeguard merchandise on our premises. We maintain no liability for loss, damage, or destruction of any consigned items by fire, theft, accident or cause of any kind.

By signing this agreement, you affirm you have read and fully understand ALL the terms outlined in this document and that you are, indeed, the lawful owner of the merchandise you have brought to us.

The consignor can terminate this agreement at any time, with 1 week's notice provided.
