Monthly Command Report

For May Emergency Response:

For the month of May, there were a total of **25** fire calls.

For the month of May, there were total of **52 911** EMS calls with **40** Transports and **12** non-transports. Of the transports, there were **38** ALS and **02** BLS calls.

In addition, there were 28 facility transfers completed.

For the month of April there were a total of 80 EMS runs.

ALS- Advanced Life Support

BLS- Basic Life Support

Average response time for the month was **08** minutes and **44** seconds. This is a door-to-door time.

Emergency Vehicles:

B-22: Apparatus is being checked daily without any major issues to report. The unit was taken to Billy Bob's to have an oil leak diagnosed. The leak was found to be due to a bad O ring on the oil pan. The proper repairs were made, and the unit is back in service. Additional repairs are still needed to repair a bad foam line and sweep sprayers. We are doing our best to minimize this unit's down time, as it is our only light brush truck and we have had a increase in wildland related calls.

B-21B (New Heavy): Apparatus is being checked daily without any major issues to report. Plumbing repairs are needed in order to have the booster line placed into service.

<u>**2** $\frac{1}{2}$ Ton 22 B:</u> Apparatus is being checked daily and is in Service without any major issues to report.

E-22: No change in status. We are still working with third party re sale vendors to secure a buyer.

E-21: OOS. The engine repairs have begun on this unit. The engine repairs have been completed. The apparatus will be released back to us once payment is received.

Loaner Engine: Apparatus is being checked daily without any major issues to report. We are responsible for any repairs while it is in our possession.

<u>**T-22:</u>** Apparatus is being checked daily and is in service. Siddons and Deep South have agreed on the repair bill. Once our Engine 21 is back in service, we will be able to schedule the repairs on this unit. We are not able to do this until E21 is released from the shop. This is so that neither station will be without an engine.</u>

M-23: Unit is being checked daily and is in service.

M-22: The medic unit is being checked daily and is in service.

<u>M-21 (New Medic Unit)</u>: Unit is being checked daily without any major issues to report. The unit went out the warranty & recall work beginning on May18th, and Siddons provided us with a loaner, free of charge. The work is set to take 2-3 weeks.

<u>Rescue 22</u>: Apparatus is being checked daily and is in service. This unit is currently being temporarily utilized as a Command unit. A POV will have to be used in it's place temporarily, in order to allow critical repairs to be completed.

MISC:

The order for the new pumper/tender has been placed with Siddons and is under construction and is on track. Our preapproval visit to the Pierce manufacturing plant is on track to take place towards the end of June or in July.

Personnel:

With the raise and benefit package roll out, we have begun to finally have relief from staffing hardships. The new benefit package is still not fully complete, as the retirement plan is still being finalized.

Administration:

Admin team is working on running self DSHS & TCFP compliance audits in order to ensure that we are holding ourselves to a high standard.

Wilson County will be upgrading its radio infrastructure to the LCRA radio system. This does require an upgrade of our apparatus and handheld radio equipment prior to January 2023.

Station:

Any public walk ups to the department are being redirected to the front doors instead on leaving the apparatus bays open. This is to ensure health safety for both the public and the personnel.

Grants/Donations:

Nothing new to report at this time.

Public Relations:

Nothing to report at this time.

<u>Fire:</u> Our biggest obstacle remains to be the age and condition of apparatus and equipment, leaving more equipment out of service than in service. This has begun to cause a decrease in the quality of relationships with surrounding departments.

EMS:

The Standard Medical Operating Protocols are currently in the final review stage. We are on our last pass of edits before a full launch.

<u>Misc.</u> A major focus point of the department remains to create a strong professional working relationship with surrounding departments and increase the number of local volunteers.
