**Monthly Command Report**

**For July Emergency Response:**

For the month of July, there were a total of **15** fire calls.

For the month of July, there were total of **34 911** EMS calls with **23** Transports and **11** non- transports. Of the transports, there were **19** ALS and **04** BLS calls.

In addition, there were **55** facility transfers completed.

For the month of July there were a total of **89** EMS runs.

ALS- Advanced Life Support

BLS- Basic Life Support

Average response time for the month was **08** minutes and **04** seconds. This is a door-to-door time.

**Emergency Vehicles:**

**B-22:** Apparatus is being checked daily without any major issues to report. Additional repairs are still needed to repair a bad foam line and sweep sprayers. Repairs will be completed as soon as we receive some rain.

**B-21B (New Heavy):** Apparatus is being checked daily without any major issues to report.

**2 ½ Ton 22 B:** Apparatus is being checked daily and is in Service without any major issues to report.

**E-22:** No change in status. We are still working with third party re sale vendors to secure a buyer.

**E-21:** Engine repairs have been completed & the apparatus is back in service. Drum straps on D3 compartment door were replaced by Siddons-Martin.

**Loaner Engine:** Apparatus is being checked daily without any major issues to report. We are responsible for any repairs while it is in our possession.

**T-22:** Apparatus is being checked daily and is in service. We are still awaiting tank repairs to be scheduled. All rear tires were replaced by Billy Bobs due to multiple bad tires.

**M-23:** Unit is being checked daily and is in service. The proper AC repairs have been completed by Siddons.

**M-22:** Unit is being checked daily without any mechanical issues to report. This unit is out of service however, due to the stretcher needing repairs.

**M-21 (New Medic Unit):** Unit is being checked daily without any major issues to report and is in service. Billy Bob's & Siddons are working on diagnosing a low voltage issue.

**Rescue 22:** Apparatus is being checked daily and is in service. This unit is still being utilized as a temporary Command.

**MISC:**

Nothing to report.

**Personnel:**

The retirement plan with TCDRS still needs to be finalized.

**Administration:**

Admin team is working on running self DSHS & TCFP compliance audits in order to ensure that we are holding ourselves to a high standard.

Our biannual audit period with TCFP is set to closed the week of July 3<sup>rd</sup> without any discrepancies found.

Wilson County will be upgrading its radio infrastructure to the LCRA radio system. This does require an upgrade of our apparatus and handheld radio equipment prior to January 2023.

## **Station:**

Any public walk ups to the department are being redirected to the front doors instead on leaving the apparatus bays open. This is to ensure health safety for both the public and the personnel.

## **Grants/Donations:**

The Command Staff is currently working on several grants.

## **Public Relations:**

Nothing to report at this time.

**Fire:** Our biggest obstacle remains to be the age and condition of apparatus and equipment, leaving more equipment out of service than in service. This has continued to cause a decrease in the quality of relationships with surrounding departments.

**EMS:**

The Standard Medical Operating Protocols are currently in the final review stage. We are on our last pass of edits before a full launch.

**Misc.:** A major focus point of the department remains to create a strong professional working relationship with surrounding departments and increase the number of local volunteers.
