# **Monthly Command Report**

# For December Emergency Response:

For the month of December, there were a total of **24** fire calls.

For the month of December, there were total of **48 911** EMS calls with **35** Transports and **13** non- transports. Of the transports, there were **32** ALS and **13** BLS calls.

In addition, there were **39** facility transfers completed.

For the month of December there were a total of **87** EMS runs.

ALS- Advanced Life Support

**BLS- Basic Life Support** 

Average response time for the month was **08** minutes and **13** seconds. This is a door-to-door time.

#### **Emergency Vehicles:**

**B-22:** Apparatus is being checked daily without any major issues to report.

**<u>5-TON</u>**: We are working on the title work, so that this unit may be taken to auction. The Forestry service has picked up their property from the unit.

**B-21B** (New Heavy): Apparatus is being checked daily without any major issues to report.

<u>2 ½ Ton 21C:</u> Apparatus is being checked daily without any major issues to report.

**E-22:** No change in status since January and is still our reserve. Apparatus still needs to be scheduled for annual PM. We are communicating with several broker agencies for used fire apparatus sales, in order to take the best avenue possible to sell it.

**E-21:** OOS No change. We are acquiring multiple quotes for repair. As soon as all quotes are received, the work will be scheduled and completed. Upon completion, the unit will go to Siddons as part of the New Engine/Tender transaction.

**Loaner Engine:** Apparatus is being checked daily without any major issues to report. The loaner engine has been upgraded to a newer model by Siddons. We are responsible for any repairs while it is in our possession.

**T-22:** Apparatus is being checked daily without any major issues to report.

<u>M-23</u>: Unit is being checked daily without any major issues to report. We are still having intermittent issues with the Ferno stretchers and power inverters. EMSAR is putting together a service agreement for this. Under a service plan, we will save more money.

<u>M-22:</u> The medic unit is being checked daily without any major issues to report. We are still having intermittent issues with the Ferno stretchers and power inverters. EMSAR is putting together a service agreement for this. Under a service plan, we will save more money.

M-21 (New Medic Unit): Unit is being checked daily without any major issues to report.

**New Command**: unit will be discussed with the acquisition committee. All estimates for the outfit have been received. The chassis we purchase will determine the final cost.

**Rescue 22:** Apparatus is being checked daily without any major issues to report. This unit is currently being temporarily utilized as a Command unit.

# **MISC:**

The order for the new pumper/tender has been placed with Siddons and is under construction

We are still working to increase our number of local volunteers.

#### **Administration**:

Command staff is working on completing detailed evaluations for all staff. We do quarterly evaluations to track progress. This particular round of evaluations will determine if staff are eligible for a pay increase, the increase will be performance based.

We will need to order at least 2 handhelds, fairly quickly.

Rescue 22 is still being utilized as a Command unit. We anticipate placing an order for a new Command unit no later than by the end of March.

We have made some changes to department operations in best interest of the department.

Captain Lopez now directly oversees department operations.

Firefighter/Paramedic/FTO Justin Flores has been promoted to EMS Captain and will directly oversee all EMS Operations.

We deployed a MICU with Emergency Medical Task Force 8 to Ulvalde, Texas to provide immediate relief to the community. Lieutenant Braiden Yow and Paramedic Rudy Hernandez were on the MICU and responded to calls in the area for a total of 5 days.

Our Medical Director Doctor Ogden purchased an ultrasound device to increase our level of service and capabilities in the field. Doctor Ogden will also be providing all training and integration with the device at no cost to the department.
