The amount to spend may be close to purchasing a new drag. New pan and cutting blades will be purchased by SnoBoss. Pan is one piece. Some bad welding will need to be grounded out and fixed. A new drag will be \$19,500. We are trying to find out if someone else can handle this fix. May have the opportunity with Alliance members to get it completed. North Groomer tracks need to be installed as well. South groomer is ready to go, West Groom is as well.
