# WHAT IS COAD?

*COAD stands for Community Organizations Active in Disaster.*

*COAD was formed to coordinate information and resources throughout Del Norte County. COAD is a non-profit organization. Members of COAD consist of agencies supplying emergency food, shelter, clothing, communication, transportation, counseling, and volunteer personnel during a disaster. COADs are active throughout the nation, but this is the first such organized effort for Del Norte County to transition from a VOAD to a COAD..*

*Del Norte County is susceptible to floods, earth- quakes, fires, and tsunamis. Large corporations, small businesses, service organizations, out-of-area non- profit groups, and individuals respond in the event of a disaster. Large and small donations of money, food, water, equipment, and other items are received and need to be distributed. People and agencies who do not usually volunteer come forward to help.*

*Del Norte County's Office of Emergency Services (OES) coordinates the activities of local, state, and federal agencies and provides information to the public via the media. Their primary contact of volunteer organizations is with the American Red Cross. The OES is not prepared to assign numerous volunteers tasks, accept and distribute truckloads of food and water, or other vital emergency activities. Members of COAD will assist in performing these activities.*

*COAD will serve as a coordinating body for these organizations, sharing information, directing resources, and screening/assigning volunteers. Complete and appropriate use of all local and state resources is required to receive federal assistance: once received, federal funds are first spent on phones, computers, damage assessment, etc. for FEMA- not food, clothing, water, shelter. Above all else, VOAD seeks to avoid a 'disaster after the disaster' where limited resources are not used well and lack of coordination results in redundant services for some and gaps in service to others.*
