Agenda Item 3: Rulebook changes- Cattle Events

- **Keep or remove calf roping;** Vote 5 to remove, 4 to keep
Calf roping will be removed
- **Add 3 man arena sorting:** Vote 6 to add arena sorting, 3 to against
Rules will be forward later on.
- **Change wild cow milking to Ribbon Roping:** Vote 6 to change, 3 against
Rules will be forward later on.
- **Require to use electric barrier first, unless one is not available, then a mechanical barrier will be used. No substitutions:** Vote 9 to add, 0 against.

Agenda Item 4: Bylaw Changes to be voted on at July meeting:

- Change starting line for Hide Race to 100ft instead of 200ft
- Speed events: Add a five second penalty for each pole or barrel that is knocked over. Barrels and poles that are knocked over do not need to be picked up.
- Remove baton: Cannot cross at the same time or a 5 second penalty will be added.
- 5-in-a-row: Use potato barrels to mark the starting line instead of poles. Change length between poles and barrels from 40 feet to 30 feet, or adjusted to the arena.
- Keyhole: Each rider will ride their horse from the starting line through the neck into the interior of the keyhole, execute a turn to the right or left, return back through the neck and across the starting line.
- Trailer Race: The contestants must reenter the truck cab, close the doors and then turn on the lights and time will stop
- Barrels: Change wording Contestants may go either to the right or left barrel but must go around the barrels either one right or two lefts or on left and two rights in the cloverleaf pattern.
- Single events: Change electric eyes to more than 30 feet apart. Put near fence.
