

## Firearm Record Number :

Guns of Distinction Store Policies  
for  
Sales, Purchases, Lay Aways, Evaluations, Cleaning, Repairs & Consignments.

1. All sales are final. If any DROS background check results in a denial, the firearm(s) may not be delivered. We will agree to put your firearm on consignment or offer you a cash purchase, depending on our interest in the firearm. Signing your DROS Record of Sale, constitutes a contract for sale. If the cannot be delivered, you waive any objections to your credit card company. If we decide to offer a refund, there is a \$100 deduction for denial paperwork.
2. The only warranty that exists on any firearms is the original factory warranty, if it is still in force. There is no warranty on previously owned firearms. You may have a gunsmith inspect any firearm before you purchase it, on our premises.
3. Auction fees, transaction fees, shipping fees, if any are deducted prior to establishing the net proceeds, upon which the commission is determined.
4. Customer has a duty to pick up the firearm(s) in a timely fashion. Firearm(s) must be picked up within 21 days, of its available release date, or there will be a storage fee of \$5 per day, per firearm. If the cost of the storage fee matches or exceeds the wholesale value of the firearm, the store may take it into inventory to recoup or offset the accumulated storage fees.
5. Firearms accepted for transfer from another FFL on customer's behalf, must be legal in California and the customer must be able to obtain DROS clearance. The fee for processing such firearms transfers is \$100 or ten percent of the sale price, whichever is greater, not including DROS fees or shipping costs. If it is not deliverable, there is a \$100 fee to return it to the original shipper, plus the shipping costs.
6. Receiving or sending a firearm to or from another FFL, is done solely at the discretion of Guns of Distinction and must be pre-approved. Firearms sent to Guns of Distinction without prior approval may be refused or may be returned to the original sending FFL, per paragraph 5.
7. All notices will be considered properly delivered if sent via email or first class us mail to the customer's address, as listed either on this form or on the DROS paperwork.
8. Consignment firearms must be left with us for a minimum of 180 days and must be picked up, upon request, within 21 days of being notified, or storage fees of will accrue, per paragraph 4. Seller is responsible for the \$47.19 redemption fee and understands there is a ten day waiting period for redemptions. Firearms redeemed prior to the 180 days, are subject to a \$100 fee.
9. No other terms or conditions, not contained in this document are valid or enforceable. No verbal agreements may modify the terms herein. This documents contains the complete agreement between Guns of Distinction and the customer.
10. Payments are processed on the last day of the month, after the firearm is delivered to the buyer. Payments on consignment firearms will be mailed to the address written below.
