## Declaration

I/We acknowledge, understand and agree that:

- 1. I will be an <u>ACTIVE member of the club</u> and wil assist with track preparation/working bees prior to club events and flag marshal ing and other duties at club events whenever possible.
- 2. Motor Racing is a dangerous recreational activity which involves a significant degree of risk of physical harm to me/us.
- 3. There are risks in go karting which are obvious to me/us as a reasonable person/people ("obvious risk").
- **4.** As a matter of law, I/we have no right to claim compensation from anyone if I am/we are harmed because of an obvious risk materialising while I/we am/are go karting.
- 5. I am aware that other drivers may drive with limited skil and ability.
- 6. I voluntarily assume all risks associated with Motor Racing and other activities.
- 7. I RELEASE NSW Outlaw Karts Inc from all claims and cost I/we would otherwise have or be able to bring if I am/we are injured or killed or if any of my/our clothing or other property is damaged or lost while I am/we are at the premises regardless of how that injury, death, damage or loss happens and even if (by way of example) it happens as a result of:
  - a) The negligence or recklessness of someone else (including NSW Outlaw Karts Inc);
  - b) The design, construction, condition, adequacy or suitability of the karts, track, equipment, services, amusements, land, buildings, car parks, paths,
  - c) landscaped areas or other improvements or facilities at the premises;
  - d) Any omission, inadequacy or error in any training or instructions that I/we or anyone else is given or in any rules or regulations made or procedures adopted by NSW Outlaw Karts Inc.;
  - AND I accept liability for and wil indemnify and keep NSW Outlaw Karts Inc. indemnified against any claims and costs.
- 8. I also accept liability for and wil indemnify and keep NSW Outlaw Karts Inc. indemnified against any claims or costs arising from any injury or death to any person and any loss of or damage to any property which arises out of my/our negligence or recklessness while I am/we are at the premises.
- 9. I will comply with all rules, regulations, procedures, training, information and instructions made or given by NSW Outlaw Karts Inc.
- **10.** I authorise NSW Outlaw Karts Inc. to take photographs, film and other images of me/us while I am/we are at the premises and to develop, print, reproduce and use them free of charge for any purpose (including commercial advertising and promotions).

- 15. Should the club reject a membership application for any reason the Membership Fee wil be refunded to the applicant in ful.
- **16.** The club reserves the right to cancel the existing membership of any person or family without negotiation or explanation.
- 17. Al approved "new memberships" wil endure a probation period of 3 months.
- **18.** Should a membership be revoked during the probation period; the applicant will receive a full refund of the membership fee.
- 19. Should a membership be revoked and/or cancel ed after the probation period has expired, no refund wil apply.
