"Viva Alfa Romeo" 2023 is the Mid-Florida AROC's annual Viva Alfa Romeo Car Show.

This gala event, scheduled for November 4th, 2023, is strictly for Alfa Romeos of all years and models, and vintage Fiat automobiles.

The purpose of this event is to strengthen the bonds of fellowship among all participating Alfistis and Fiatsis, to recognize those who strive to maintain autos of rare design or condition, and to provide a venue where we may display the virtues of our cars to the general public.

The site we have chosen again is Market Street in the heart of downtown Celebration, Florida. The town has agreed to cordon off their main street for our show site. The Town of Celebration draws visitors from around the world. The location is ideal for attracting a large number of spectators during the entire time of the exhibition.

Those who participate by exhibiting their Alfa Romeos & Fiats during the show will receive a welcome bag of memorabilia, nice prize drawings, and will be eligible for awards of excellence based on the judging of their cars.

Directions to Celebration Show Site:

From the *north*: I-4 West to exit #64 to U.S. 192 East (Kissimmee/Celebration). Turn right on Celebration Avenue to Market Street.

From the *east and south*: I-95 to Beachline (Toll 528 West) exit onto S.R. 417 South. Take exit #2 toward U.S. 192 East. Take ramp to Celebration. Turn left on Celebration Avenue to Market Street.

From the **west**: I-4 East to exit #64. East to U.S.192 East (Celebration). Turn right on Celebration Avenue to Market Street.

From *northwest*: Florida Turnpike South to exit #289. Follow U.S. 27 South and merge onto U.S. 192 East. Turn right on Celebration Avenue to Market Street.

- 2. Pets or animals of any nature or type are not allowed at the event, except for those whose owners are sight impaired or disabled.
- 3. As a condition of displaying their cars, exhibitors agree to leave their cars in place from 8:30 a.m. to 4:00 p.m. on 11/04/2023.
- 4. Only qualified and **registered** vehicles will be guaranteed a parking place in the exhibitors' area.
- 5. Canopies, banners or other signage relating to exhibitor cars or other interests are not allowed, with the exception of a descriptive placard, which may be positioned directly in front of the car or on the dash. "For Sale" signs are prohibited unless written permission is received from the show organizers in advance of the show.
- 6. All exhibitors are required to have full insurance policies in effect for their display vehicles.
- 7. No soliciting is allowed including, but not limited to, handing out of any material, brochures or offerings of any kind without the written permission of the show organizers in advance of the show.
