

2024 Region 9 AHA Championship Show May 28 – June 1, 2024

On behalf of the Show Committee for the Region 9 Arabian Horse Association Championship Show to be held at the Will Rogers Memorial Center Complex in Fort Worth, Texas, I would like to invite you to be an exhibitor. We anticipate approximately 500 Purebred and Half-Arabian horses with their trainers, owners, and guests. The classes range from Halter through English, Native Costume, Hunter, Trail, Western, Working Cow and Sport Horse. This show should serve as an excellent venue for you to present your product/service to a wide variety of individuals.

The show starts at 8:00 am Tuesday May 28, and concludes on Saturday, June 1. Move in date for commercial vendors will be **Monday May 27 or Tuesday**, **May 28 at 8:00 AM**. Your exhibits must be set up no later than 9:00 PM on that day. No tear down of booths will be allowed before 5:00 pm on Saturday, June 1, 2024. **Move out date is June 1 not before 5:00 PM**. If needed, each booth will be back draped and have one 8' table and 2 chairs per 6' x 10' booth; additional tables and chairs may be ordered with no extra charge. **Commercial Exhibitors** <u>must state</u> <u>how many tables and chairs are needed and if back drapes are wanted. If not noted, none will be provided</u>. All commercial vendors will be in the concourse of Will Rogers Coliseum unless arrangements are made to be elsewhere.

Parking at Will Rogers: The facility is charging a parking fee for automobiles (\$6/day) in the facility parking lots. Parking passes are in-and-out passes – you do not need to repay the \$6 each time you enter the facility THAT DAY. A different fee is charged for trailers, \$6 or \$12/day depending on where you park your trailer. Fees will be collected at facility entrance points when you arrive. Region 9 will provide one parking pass for one vehicle from May 28- through June 1, 2024. You may pick up your parking pass from Beth Walker, Show Coordinator's office upon arrival on the show grounds. You can order additional parking passes from Beth Walker in advance of the Show or online at tgray@dickiesarena.com but there is a \$2 per day service charge added to the daily fee per car and per trailer. The Region 9 Championship Show does not benefit in any way from the collected parking fees.

Please complete the application and release document, return it with your \$100 deposit or full payment by April 1, 2024. Balance is due by May 1, 2024. If you are reserving a booth, please remember that space is limited, and priority will be based on receipt of the full booth payment. If you are interested in space outside, please be aware that there is no way of guaranteeing the security of your property. If full payment is not received by the due date, your space will be available to another exhibitor.

Preference on location will be based on date of receipt of **full payment**.

Cancellations must be received in writing. Cancellations prior to April 30, 2024 will receive a refund of the amount paid minus the \$100 deposit. No refunds will be made for cancellations after May 1, 2024.

Booths located inside Coliseum Lobby area: (See dates above.) Applicant agrees to move in and be set up by 9:00 PM Move-in Day. Each booth is to be open and properly manned throughout Exhibit Hall hours. Booths are to be cleared out by 10:00 pm, Move-out Day. Please, no move-out prior to end of Exhibit Hall hours on the last
