

Anderson Island Park & Recreation District

Resolution 2017-2

A resolution of the Board of Commissioners of the Anderson Island Park and Recreation District, Pierce County, Washington, providing for submission to voters of the District, at the general election to be held November 7, 2017, of a proposition authorizing the levy of a general tax on taxable property within the District, as authorized in RCW 36.69.145 to provide funds required by the Park and Recreation District for maintenance and operation of facilities within the District for the years 2018-2023, said levy to be in the sum of \$0.40 per \$1000 of assessed valuation, to be collected for six consecutive years, beginning in 2018.

Whereas, the Anderson Island Park and Recreation District owns and operates facilities for the benefit of its residents and taxpayers; and

Whereas, the District is authorized by law, upon approval of the voters, to impose tax levies and to use tax revenues for the maintenance and operation of parks and recreational facilities; and

Whereas, the District does not now have, nor does it anticipate obtaining elsewhere, sufficient funds to implement its maintenance and operating programs beyond the year 2018; and

Whereas, in order for the District to obtain such funds to maintain and operate its facilities, an election should be held, as set forth in RCW 36.69.145, to authorize a property tax levy to raise funds for the District; **now therefore**

Be it resolved by the Board of Commissioners of the Anderson Island Park and Recreation District, as follows,

SECTION 1. For the purpose of raising revenues adequate to pay costs attributable to providing adequate park and recreation facilities in the District for the years 2018 through 2023 the District shall levy a general tax on taxable property within the District in the amount of \$0.40 per \$1000 of the true and fair assessed valuation of the District.

SECTION 2. The Pierce County Auditor is requested to call and conduct an election in the District in the manner provided by law to be held therein on November 7, 2017, for the purpose of submitting to the voters of the District, for their approval or rejection, the question whether or not such levy for maintenance and operation should be made. The Board of Commissioners hereby resolves that the Auditor of Pierce County, as ex officio of election, is requested to call said election in the form of a ballot title substantially as follows:

PROPOSITION 1
ANDERSON ISLAND PARK & RECREATION DISTRICT
REGULAR PROPERTY TAX LEVY FOR MAINTENANCE AND OPERATIONS

Will the Anderson Island Park and Recreation District be authorized to impose regular property tax levies of \$0.40 per \$1000 of assessed valuation for each of six consecutive years, so as to continue to maintain and operate park and recreation facilities on Anderson Island?
