Secretary's Report: Amanda Daugherty accepted Secretary Position.

Minutes from previous Board meeting were submitted for review. Henry Tobin made motion to approve minutes as submitted. Ron Wilson seconded. All present in favor,

Treasurer's Report: Treasurer Tobin reported in 2022/2023 \$51250 in dues was taken in and \$50,000 was

spent according to budget.

GHPOA QuickBooks is in the process of being updated to the most recent version with the assistance of CPA, and GH Resident, Gregory Allen. Balance of outstanding dues/fees is \$6193, which is derived from 7 separate property owners. One property is in the process of having a lien filed against it for outstanding dues/fees, while two properties had foreclosures filed against them. One property with \$1500 outstanding dues/fees was

seeking refinancing, so the HOA monies will be recovered at closing.

Vice President Wilson suggested President Petty review the steps of lien/foreclosure (ROI) process at the annual meeting, so residents have a better understanding of how the board

recovers outstanding community money.

Director Lyons indicated even cold tolerant plants didn't survive the harsh winter we experienced. He personally managed our irrigation during times of frost to help preserve the community's plants.

Jason to meet with Amanda Daugherty and Russell Evans to discuss potential solutions for the curve at the beginning of the community, as this area has become hazardous with multiple accidents occurring.

Old Business:

Speeding: Community speeding issues discussed with Lt. McQuaig, the Board previously retained the services of off duty officers to patrol the community to help curb speeding on our streets, as well as to provide a law enforcement presence within our community. . . Motion by Amanda Daugherty for Reinstatement of sheriff's office patrol. Ron Wilson seconded the motion and suggested that Tuesdays & Thursdays would be good patrol days.

Lighting: Front entrance will be more illuminated as "guardhouse" interior and exterior lights will be left on. Suggestion made to tint windows of building.

Lighting will be addended on 42 lane by MSTU. City to run electric with city engineer is deciding whether new street lights will be staggered or parallel.

Speeding: Vice President Petty informed the board new speed limit signs shall be placed throughout the community
