# Women's Championship Tournament Rules

Please Read Carefully

## 1. Eligibility

All women entering the Arbor Valley USBC Assn. Women's Championship Tournament must be members in good standing in the USBC. Unmarried grade and high school students who have not attained the age of 18 must furnish a consent form signed by their parent or legal guardian. Consent form must be filed with the tournament manager before student bowls.

**ALL ENTRANTS MUST BE FEMALE MEMBERS OF THE ARBOR VALLEY USBC ASSN.** Bowlers who are members of multiple local associations must have a current season 21 game average within the Arbor Valley USBC Assn. or a 2017-2018 Arbor Valley USBC yearbook (including summer league averages) average of 21 games or more.

## 2. Scoring

The scoring will be on a handicap basis, and will be computed by adding 90% of the difference between the bowler's average and 230 scratch and will be computed on a three game series basis. There is no negative handicap.

**USE HIGHEST AVERAGE FROM ANY CERTIFIED LEAGUE ANYWHERE.**

Entrants in the Arbor Valley USBC Women's Championship shall use their highest certified YEARBOOK average from the previous (2017-2018) season in **any** USBC association, provided they have bowled 21 games or more. 2018 Summer League averages of 21 games or more are considered YEARBOOK averages. If entrant has no yearbook average from 2017-2018 they will use their highest current certified season average as of December 31, 2018 provided they have bowled 21 or more games. If the entrant has none of these averages they may use their highest current certified league average of 21 or more games as of the date of their participation. Proof of this current average must be provided to the tournament manager prior to participation in any event. Failure to provide this documentation (league standing sheet) will result in the bowler using a 230 scratch average. **If any bowler's HIGHEST average of games bowled through December 31, 2018 is ten (10) pins or more higher for twenty-one or more games in any USBC certified league than their highest YEARBOOK average for 2017-2018 of twenty-one or more games, then they must use their highest average as of December 31, 2018.**

USBC rules 319.c (rerating) and 319.e (tournament average) will also apply. Rule 310d (reporting prize winnings) is waived.

Any eligible entrant who has no average meeting the above requirements may enter and bowl without the benefit of handicap.

It shall be each bowler's responsibility to verify the accuracy of their average in this tournament, whether originally submitted by the bowler, their team captain, or others. Correction of averages can be made up to the completion of the first game of a series or within 48 hours of the completion of a series if the tournament manager, prior to the completion of the first game of the series, has given written consent to the bowler authorizing extension of time to correct their average. **Failure to use the proper average or make a correction prior to or at the time of bowling shall disqualify their scores if the submitted average is lower than actual average and increases the individual's handicap.** Prize winnings will be based upon the erroneous submitted average if it reduces the individual's handicap.

Scoring errors must be brought to the attention of the Tournament Manager within 72 hours of the completion of the series or the scores will not be corrected.

Handicap game will be capped at 300 and handicap series capped at 900.

In case of a tie for first place in any event, co-champions shall be declared. First and second place money shall be divided equally.

## 3. Entry Fees

Entry fees shall be \$20.00 per person per event (\$8.55 lineage, \$2.00 expense, \$9.45 prize fees). Optional team actual entry is \$50.00 per team. Optional events entry fees are \$5.00 per person for actual singles, actual doubles and actual and handicap All-Events. Prize fees will be returned 100% in prizes. Ratio of HANDICAP prizes will be at least one prize for each 6 entries except All-Events Handicap, which will be at least one prize for each 12 entries. Ratio of actual prizes will be one for each 12 entries.

All fees must accompany the entry blank. All entries fees must be in the hands of the Association Office or postmarked by January 31, 2017. Deadline for teams with reservations is Saturday, January 21, 2017. Walk-In team and singles/doubles entries are allowed when lanes are available. There is a \$10.00 additional fee per team and per singles/doubles entry for walk-in entries. Walk-in entries close ½ hour prior to squad time.

**THERE IS A \$30.00 FEE FOR ANY RETURNED CHECKS, WHICH MUST BE PAID BEFORE PARTICIPATING IN THE TOURNAMENT!**

## 4. Participation Restrictions

A bowler may compete up to three times in the team and singles/doubles events. Not more than three players can compete together more than once in the five-person team event. The same doubles pairings cannot compete more than once in the doubles event. Bowlers may cash up to three times in the singles and doubles events. When a bowler participates more than once in the five-person team or singles/doubles event their first score in the event shall count towards their all-events scores. Only two bowlers who have belonged to the PBA during the last 24 months will be allowed on each team. Only one bowler who has belonged to the PBA during the last 24 months is allowed on each doubles team. **Entrants in doubles event must bowl in singles event, and vice versa.**

All-Events: A replacement may be made in the All-Events providing the replacement is made before the original entrant and their replacement have bowled in the tournament.

## 5. Lane Assignments and Rosters

The Tournament Manager may pair teams according to averages. Two teams may request to be paired together if they notify the Tournament Manager at least five days before the squad. Teams will bowl all three games on the same pair of lanes.

The Tournament Manager will assign the starting lanes for Team, Doubles and Singles by random draw. Doubles and Singles will be bowled on the same pair of lanes.

The line-up of the Five-Person Team and Doubles Events will be printed as written on the entry blank unless the Captain gives the Tournament Manager five (5) days advance notice of the change. Substitutions may be made when the team Captain checks in. Substitutes will take the bowling order position of the person being replaced.

## 6. Protests

USBC playing rules shall govern situations not addressed in these rules. All decisions of the Tournament Manager are final unless an appeal is made in accordance with USBC Rule 329.
