ADDRESS

Commissioner Hemsley Facebook Posts Investigation:

Commissioner Hemsley stated that he strongly denounces racism, homophobia, and anti-Semitism. He apologized and says he will continue to apologize to this community, his family, and friends for dragging everyone through these allegations. He thanked the people who stood up for him and could see the person that he really is. He stated that the Board reviewed his Facebook before he was appointed, and that either the posts were there and they were ignored, or the posts were never there.

Commissioner Hemsley stated that after being appointed, he started to receive sensitive information about lawsuits in this District. He said that it is his opinion that when the taxpayers of Oceanside are able to see what was and is going on with their hard-earned money, they are going to be furious. It is also his opinion that the wasted millions on excess litigation and fees seems criminal. He states that when he began to seriously question these events, he was attacked, and questioned if this was a coincidence.

Commissioner Hemsley stated that there is a thirty-five-million-dollar sexual harassment lawsuit pending against the District, and yet no one was asked to resign. He suggested that perhaps they (the commissioners) should all resign together. He says that the current commissioners have recently offered him a deal that if he were to step down immediately, the other commissioners would not run anyone against him in the next election. He also stated that during the most recent election, he was warned that the anonymous package (a print-out of the racist, homophobic, ableist, and anti-Semitic Facebook posts allegedly belonging to Commissioner Hemsley) would be released if he did not follow his fellow commissioners' election requests.

Commissioner Hemsley stated that he will continue to be as transparent as possible to the Oceanside taxpayers, but that these are very serious allegations with serious consequences. He stated that he cannot and will not say anything to anyone until a full and thorough external investigation is conducted. He stated that when the investigation is conducted, he will have a lot to say, and evidence to back up his statements.

Commissioner Hemsley apologized to Oceanside.

Commissioner Samoles responded by stating that it is an outright lie that he saw Commissioner Hemsley's Facebook posts before he was appointed. He reiterated that he never saw Commissioner Hemsley's Facebook posts before he was appointed and continued, saying that Commissioner Hemsley owes the autistic and special needs community an apology.

Commissioner Doherty stated that he has spoken to Commissioner Hemsley many times and that he was shocked by the posts. He stated that Commissioner Hemsley mentioned something about the Board offering him a deal and stated that he has no knowledge of any deal being offered. He said that he has nothing to do with a deal being made with Commissioner Hemsley and that if it is true that a deal was offered, something is wrong.

Commissioner Doherty went on to say that everyone has skeletons in their closets, and that it is a no-win situation. He stated that they as a Board have asked Commissioner Hemsley to resign and that he has refused to do so. However he admitted that the posts were all made before Commissioner Hemsley became a commissioner, and said that there isn't much else to do but apologize. Commissioner Doherty continued, saying that he was not present when Commissioner Hemsley was appointed and that he is disheartened by the whole situation.

Commissioner Doherty concluded by stating that he has always had good experiences with the commissioner and that he isn't there to be judge and jury for Commissioner Hemsley.

Commissioner Mannone stated that he had no idea of the Facebook posts, until, roughly, when the information was disclosed to the Board. He went on to say that this attempt to say that it existed and that they knew about it is a complete and utter fabrication.

Commissioner Doherty stated that they, the Board, don't know if that is true.

Commissioner Mannone continued, saying that the deal that Commissioner Hemsley alleges to have been offered is utter nonsense. He stated that they all asked as a Board, in executive session, that Commissioner Hemsley step down, because he made those posts, and to,

therefore, not put the community through a nightmare in order to try and justify inappropriate behavior. Commissioner Mannone said that whether the posts were made three years ago or five years ago, it was recent history. He stated that it was a kind and honest suggestion to Commissioner Hemsley to step down, because the posts are simply inappropriate for our community, as well as for someone who holds public office.

Commissioner Mannone stated that it is fine for Commissioner Hemsley to, in his private life, make jokes and be a comedian, but it is inappropriate for someone who holds a position on a public Board of Commissioners. He stated that other commissioners may disagree with him, but that he believes that the right thing to do is to step down.

Commissioner Graff stated that he has been attacked by Commissioner Hemsley as well as his supporters because of the allegations that he knew what was on Commissioner Hemsley's Facebook page. Commissioner Graff insists that he never knew about the horrific, disgusting material posted there. Commissioner Graff further explained that Commissioner Hemsley told him in a text message that it took him about an hour to remove things from his Facebook page, and Commissioner Graff's response was that he would not be surprised if people had already taken pictures of the material. He said that it is his understanding that the posts in the anonymous packet were not even under Commissioner Hemsley's name; they were posted under the name Pauly Sandwiches. Therefore, how could he have known about the posts, if they were under a different name? Commissioner Graff continued, saying that all he was told was that there was a series of 'Go *F* Yourself' comments for Commissioner Hemsley to remove.

Commissioner Graff stated that he tried to arrange a deal where Commissioner Hemsley would step down and then allow the citizens of Oceanside to vote again this year to decide whether or not Commissioner Hemsley would return to serve on the Board. Commissioner Graff explained that he suggested that perhaps the Board would not fill the position left vacant by Officer Hemsley, so that he would not be running against an incoming commissioner. Commissioner Graff stated that this was his suggestion, and that he was not representing the Board when making that suggestion. He said that Commissioner Hemsley decided that he would not step down, and that they would have to accept that he will continue to be a commissioner for the next year and a half.

Commissioner Graff stated that the Commissioner Hemsley investigation is on the agenda under 'Unfinished Business'. He stated that he has communicated with a law firm that can do an investigation, and, in executive session, with legal advice, he would like to discuss the issue with the other commissioners, outside of Commissioner Hemsley's presence. Commissioner Graff explained that he would rather not incur unnecessary costs in order to investigate Facebook posts that Commissioner Hemsley has already admitted were his. He further stated that since Commissioner Hemsley insists, they will have to cost the taxpayers money.

Commissioner Graff concluded by reiterating that he did not know about the posts, and that if he had known about them, he would never have supported his candidacy. He said that he is Jewish and that the anti-Semitic material in the posts was so disgusting to him that it turned his stomach. Commissioner Graff again insisted that he did not see it, and that any allegation that he did see it, is a blatant lie.

Commissioner Doherty stated that the Board should wait until the investigation has been concluded before allowing questions regarding the allegations to be asked of Commissioner Hemsley. He stated that, since Senator Todd Kaminsky advised them that there was no law that allowed the Board to remove Commissioner Hemsley, it was his opinion that they should stop discussing the issue and allowing it to continue to defame the Oceanside Sanitation Department. He said that he understands that people are offended, but that we need to try and stop talking about it and move on so that we can all go back to doing our jobs. He said that we should wait until the investigation is over before continuing to talk about this issue.

Commissioner Hemsley asked why he cannot be present in executive session while the independent investigation is being discussed.

Attorney to the Board, Mr. Ciampoli explained that the reason that he, Commissioner Hemsley, should not be there is because it involves a legal contract and it involves hiring counsel and there is an obvious conflict of interest when it comes to Commissioner Hemsley. He, therefore, cannot be allowed to vote on this issue. Mr. Ciampoli said that they have had a proposal from a law firm to do an independent investigation, and that he

has heard everyone here say that they think they should do the investigation. Mr. Ciampoli assured Commissioner Hemsley that he, personally, would make sure that Commissioner Hemsley receives all pertinent information and that everyone has an opportunity to present any evidence. He said that the investigation will be run properly and fairly, as it should be done.

Commissioner Mannone stated that he, personally, does not know where this is going and that there is a law that states that they, the Board, cannot remove Commissioner Hemsley from his position. He said that there is a bill being proposed that would change the law, but explained that the law is not the issue. He continued, saying that Commissioner Hemsley has asked for an independent investigation and that he assumes the Chairman will propose that they conduct an independent investigation.

Commissioner Mannone said that the real issue is that this story has spread around the world and that the world is now watching five ordinary guys to see how they will handle this and whether they will handle it fairly and judicially, and bring justice or not. He stated that there are a lot of people in the community, though he believes it is a small segment, that support Commissioner Hemsley, but their attitude is that we should put this issue away and just pick up garbage.

Commissioner Mannone said that somehow life and circumstances and Commissioner Hemsley's posts have thrust them into a much broader, much more significant, and morally important question. He says that he thinks they have to be fair about it, and try to ascertain the truth here. Commissioner Mannone went on to say that Commissioner Hemsley has said that some of the material is not his, while some of it is from him. Commissioner Mannone says that he cannot be sure because Commissioner Hemsley will not speak with them to answer that simple question, but nevertheless he wants an independent investigation. Commissioner Mannone stated that he doesn't blame Commissioner Hemsley for wanting an independent investigation, because he imagines that the commissioner must feel that he is under siege. He concluded that they, the Board, owe it to—not just Oceanside—but the state, the country, maybe the whole world that is watching now, to do the right thing.

Commissioner Graff asked if anyone else had comments. All commissioners gestured to indicate they had nothing more to add. Commissioner Graff asked Commissioner Hemsley if he would like to respond. Commissioner Hemsley declined.

Sensitivity Training and Partnership with Organizations to Hold Seminars and Meetings with Community:

Commissioner Graff stated that since the situation with Commissioner Hemsley has been made public, several organizations have approached him as well as Mr. Ciampoli to hold sensitivity training and partnerships with organizations on issues of race, religion, and other issues that affect the community.

Commissioner Graff stated that he put it on the list for New Business, because he wants to start having conversations around the issue. He says that he is unsure of logistics during the time of Covid, but wants to start the conversation about having some trainings and partnering with certain organizations. He asked the Board if they have any objections to that conversation.

Commissioner Samoles stated that he did not have any objections and asked for more information about who has approached Commissioner Graff and Mr. Ciampoli.

Mr. Ciampoli stated that they have a list of several organizations that specialize in various phases of anti bias activities. He continued to explain that they offer sensitivity training, so that you learn how to think before you speak, and learn to think about what you are saying and how it may be offensive, and how to avoid those situations. Mr. Ciampoli said that he thinks it is a good opportunity and that it is important, given the past recent events in this District, for them to do something affirmative. He said, also, that in some cases, the organizations are willing to do these trainings at no cost to the District.

Commissioner Doherty asked what organizations approached him about the trainings.

Mr. Ciampoli responded that he did not have the list with him, but that they have been in touch with the local NAACP, an anti defamation league affiliate, and a holocaust memorial organization. He offered to seek out other organizations, as well, if the commissioners wish.

Commissioner Doherty asked if these organizations were the ones that offer training.

Mr. Ciampoli responded that yes, these organizations do offer bias training for better sensitivity and a workplace that is inoculated against this.

Commissioner Doherty stated that he thinks it would be worthwhile to pursue this, but wants to make sure that it is training that would benefit the District. He said that it should not just be done in response to the allegations.

Commissioner Mannone stated that he thought it would be good to at least hear their ideas.

Mr. Ciampoli explained that it is his understanding that the organizations are offering their services in order to give the District some guidance as opposed to giving criticism. He stated that this is proactive, preventative, and designed to make this District work better.

Commissioner Graff stated that he and Mr. Ciampoli will make arrangements and will hopefully, by the next meeting, have some dates

scheduled for the trainings. He said that if it does not incur any costs, then, obviously, that would be best, and if it does incur any costs, they would come before the Board and seek approval.

Commissioner Doherty asked if this training would include all of the employees as well.

Mr. Ciampoli responded that yes, it would include the employees. He further explained that if they chose, as a Board, to make the training mandatory, that would also come before the Board for approval.

Commissioner Doherty said that he thinks they should find out what the training would entail, before deciding that.

Commissioner Mannone suggested that Commissioner Graff and Mr. Ciampoli get more information, come up with a plan, and report back to the Board. He also suggested that perhaps they could meet with the organizations before making a decision.

Commissioner Graff and Mr. Ciampoli both agreed.

PUBLIC
COMMENTS

Commissioner Graff stated that he posted a request on the Oceanside Facebook page that any residents who wish to make a public comment kindly send an email. He said that he received a series of emails and he will read them aloud and then let the Board respond.

Susan Nadler: Why aren't your audited 2019 financial statements posted on your website?

Commissioner Graff responded and said that they were posted on the website and explained that there was a problem with the website—it was put in a hidden file. He stated that it is now posted as of Saturday or Sunday.

Susan Nadler: Please ensure that each person that speaks is at a microphone so we can hear what is being discussed. Oftentimes, a good portion of the meeting is not audible.

Commissioner Graff responded, saying that, as they could see, he tried to take the microphone and move it around so that everyone could be heard. He said that hopefully everyone could be heard.

Commissioner Samoles commented that they have five microphones.

Commissioner Graff explained that those microphones do not connect to the YouTube video.

John Loonie: For many years, we have put up with nothing but controversy, corruption, and legal costs involving the Oceanside Sanitation District. My question is: Why do we still have a special district? What benefit is there for residents and taxpayers of Oceanside? Why was a special district formed, rather than utilizing the services of the Town of Hempstead, which we all pay taxes to? Was it formed for the benefit of Oceanside, or a cash cow for the administrators? Can anyone answer these questions?

Commissioner Graff responded, explaining that this district was formed in the 1930s. He stated that he cannot tell from the history why it was formed, but obviously the people of Oceanside decided that they needed a sanitation district.

Commissioner Mannone explained that Oceanside Sanitation District was formed in 1929 in a time before the Town had the ability to provide sanitation services. He said that, at the time, to support the growing suburb that was just starting back then, they set up special sanitation districts throughout Long Island and some of them have survived to the modern day. Commissioner Mannone explained that the residents do not pay double tax for sanitation pickup. He said that they pay for sanitation pickup through the sanitation district here, and the Town does not charge you for that pickup.

Commissioner Mannone commented further, saying that sometimes there is controversy and sometimes there is not, but that the advantage of a local district, is local, community control over it. He stated that he thinks it is fair to say that you get a much higher quality of service through any of the special districts than you do through the Town, because it is a larger entity. Commissioner Mannone acknowledged that it does cost slightly more, and that they have been attempting to lower the taxes. He stated that one of his personal goals, as well as the goal of

the Board, is to bring the taxes down so that they are at the same level as those of the Town. He said that this would create a situation where you get a high quality service at the same price.

Commissioner Graff said that he hoped that answered Mr. Loonie's question.

Mike Gregoretti: Hi Austin. I would have liked to come to the meeting this Thursday. As you know, I am upset with the way you handle yourself on Facebook. I am curious to know how much time you spend on Facebook and why you feel it is okay to post opinionated statements about Ryan and use it as a tool to speak to the community. In my opinion, you are causing turmoil within the community, and putting people up against each other. Why do you support this type of behavior? Why do you "advertise" your agenda on Facebook? You and the people that support the bashing on Facebook are making this town look bad. Can we ask questions on the virtual meeting? I am nine-five percent sure that you and John will not touch this subject with a thirty-foot pole.

Commissioner Graff responded, saying that he is touching this subject and that he will respond to Mr. Gregoretti. He stated that he does not spend a lot of time on Facebook. He said that there are times when people on Facebook comment on sanitary matters, and I respond as quickly as I can to make sure that the District is responsive to the taxpayers—the residents—and we get the garbage picked up. Commissioner Graff stated the he understands that Mr. Gregoretti is upset with him and that he has made himself clear on several of Commissioner Graff's posts, as well as outside of Facebook, that he is upset about the way he has handled the matter having to do with Commissioner Hemsley.

Commissioner Graff continued, saying that it had upset him—the way the whole situation occurred—and reminded the public that he discussed that earlier in the meeting. He stated that he does not use Facebook for any agenda; his only agenda is the District, the taxpayers, and the employees of this District. Commissioner Graff added that sometimes the taxpayers are more important than the employees and sometimes he has to be as concerned about them as much as the taxpayers. He stated that he is concerned that the District look good, and it has not looked good all year. He said that he knows that it is embarrassing for the people in Oceanside and he apologized for that. Commissioner Graff

explained that his first attempt at resolving the situation with Commissioner Hemsley was to go directly to him and speak to him on the phone the night the Board received the packet. He stated that he did not want it to get out, nor did he want it to end up all over the news, but it did.

Commissioner Graff concluded by telling Mr. Gregoretti that he should feel free to comment further about him. He stated that his philosophy on being a sanitation commissioner is that he does not always do what is popular, but that he does what he thinks is right. He went on to say that something that is popular is not always right and what is right is not always popular. He stated that the Board has to do what they think is in the best interest of the taxpayers and the employees of the District.

Question One: (for Commissioner Hemsley) Please confirm which of your offensive Facebook posts you are taking credit for, and which are you claiming are false.

Question Two: (for Commissioner Hemsley) If/when we have the facts of which posts are yours, will you then step down?

Question Three: (for Commissioner Hemsley) How do you justify accepting pay and benefits from the community, when you have skipped more board meetings than you have attended?

Question Four: (for Commissioner Hemsley) Please advise on the current status of your dedicated tactical vigilante squad and any ongoing activities you may be conducting.

Mr. Graff, I am choosing to not provide my name and use an anonymous email address out of fear of retaliation from Ryan Hemsley, who is not only the leader of a tactical vigilante squad, but also has a history of violent and hate-filled social media posts. I am an Oceanside resident and will happily work out a way for you to speak to confirm, if that is what you would like.

Commissioner Graff asked Commissioner Hemsley if he would like to respond. Commissioner Hemsley declined.

Commissioner Doherty pointed out that the memes, etc. in the packet that was sent to the District, were also sent anonymously.

Commissioner Graff said that he agrees one hundred percent.

Dave Dedonna: If an independent investigation is started about what are Ryan's posts, will he answer to them, or will this be a waste of taxpayer funds? If Ryan cares about Oceanside taxpayers, why won't he just come clean and save us all the time and money? What is going to be the next steps?

Commissioner Hemsley chose not to respond.

Commissioner Graff responded, saying that they discussed earlier on in the meeting that the Board will discuss the possibility of an investigation in executive session. He stated that they will go into executive session and then come out of executive session to vote on that.

Commissioner Samoles stated that he thinks it is reasonable to ask the question: If there is an investigation, will Commissioner Hemsley participate?

Commissioner Hemsley asked for clarification.

Commissioner Graff explained that they want to know if he will answer questions during the investigation.

Commissioner Hemsley stated that if there is an independent investigation, he will participate and answer questions.

Joe Cibellis: Did this Board give sixty-five thousand of our tax dollars to an employee of sanitation to settle a lawsuit?

Commissioner Graff responded that the answer to that is yes, and the reason is that when Mr. Cibellis was a commissioner here, he removed someone from the drivers list who was not supposed to be removed from the drivers list, and Mr. Cibellis did so only because the employee supported John Mannone in his election.

Joe Cibellis: Was this legal action drafted from and brought by sitting commissioners?

Commissioner Graff responded that no, he was the employee's lawyer, but as soon as Commissioner Graff became a commissioner, he stepped down as his attorney.

Joe Cibellis: Has the arbitration ruled against the current Board on every case to date?

Commissioner Graff stated that he does not know what “current board” means, but in the case with the sanitation employee who was awarded sixty-five thousand dollars, he actually beat the District in an arbitration, because there was no reasonable explanation as to why he was removed from the drivers list.

Joe Cibellis: Is this Board in contempt of court?

Commissioner Graff said that they are not in contempt of court.

Joe Cibellis: Are there several employees still receiving full pay?

Commissioner Graff responded, saying that all employees are receiving full pay, except for the part time employees.

Commissioner Graff stated that those were all of the questions, and asked if there were any comments from the commissioners.

Commissioner Samoles stated that it was criminal to take a fifty-year old man off of the drivers list and make him go out and load twenty thousand pounds of garbage a day. He said that it takes a physical toll. Commissioner Samoles went on to say that it also took a toll on Richie, who was out of work for an entire year, and missed out on that being included in his retirement benefits. He concluded that this was another example of wrong that the previous commissioners did against the employees and that the current Board had to clean up Joe Cibellis’ mess.

Commissioner Doherty stated that he would like to apologize to all of the workers and everyone in the front office for all of the crap that has gone on—from the Board, and Facebook and all the garbage that goes on every year with elections, because there is no district on Long Island that does a better job than the Oceanside employees—from top to bottom. He further stated that he means from those taking phone calls at the front office, to those dealing with the people, to those going out driving and doing the loading, he thinks that they all do an admirable job. He also mentioned the supervisors, the maintenance staff, and the mechanics and stated that they should not forget that those are the people who really do this job.

Commissioner Mannone said that he also wanted to thank the employees for their work and for their support during the election. He said that he knows that this situation is very distasteful. Commissioner Mannone also stated there are people in the community that are attempting to disenfranchise the majority of people, including the employees as sanitation workers and they will stop at nothing to destroy the employees' livelihoods and take advantage of the taxpayers. He stated that they have been doing it for decades, mentioning that the sanitation workers know because they have lived through it.

Commissioner Mannone concluded by saying that we are, all of us, decent people, and that decent people are the last line of defense against all of those groups that seek absolute control over our lives, taxes, and livelihoods.

MOTION On Motion by Commissioner Doherty to go into executive session. Commissioner Mannone seconded the motion, and it was unanimously approved. Motion passed.

EXECUTIVE Commissioners Graff, Mannone, Doherty, and Samoles, and Attorney SESSION Ciampoli went into executive session.

MOTION On Motion, by Commissioner Hemsley to return from executive session. Commissioner Mannone seconded the motion, and it was unanimously approved. Motion passed.

MOTION On Motion, by Commissioner Mannone to appoint the Chandler Law Firm, PLLC at the rate of two hundred and seventy-five dollars per hour for senior attorneys and above counsel, and one hundred and seventy-five dollars per hour for paralegal and legal assistants to conduct an investigation regarding Ryan Hemsley's Facebook page.

Commissioner Mannone requested that a seventy-five-hundred-dollar limit be put in place, and that it be required that the law firm seek approval from the Board before going over that amount. Commissioner Graff agreed to add a provision that states there will be a cap of seven thousand, five hundred dollars and that anything above would be subject to approval.

Commissioner Samoles seconded the motion, and it was approved by Commissioners Graff, Mannone, Doherty, and Samoles. Commissioner Hemsley abstained. Motion passed.

Commissioner Graff stated that there has been a request from Zachary Jefremow to take a leave of absence to join the Coast Guard reserves. He said that, on behalf of the Board, he would like to wish him luck and thank him for his service.

MOTION

On Motion by Commissioner Doherty to approve Zachary Jefremow's leave of absence to join the Coast Guard Reserves. Commissioner Samoles seconded the motion, and it was unanimously approved. Motion passed.

Attorney John Ciampoli stated that, at prior meetings, this Board has approved the settlement of certain litigations and Union grievances with Daniel Faust based upon prior actions. He stated that he had a resolution, which he read aloud:

Whereas this Board of Commissioners terminated General Supervisor Daniel Faust from his employment with the District in 2018, and whereas Daniel Faust contested said termination by way of Union grievances and litigation, and whereas said grievance proceedings and litigations before the New York State Supreme Court, were universally settled which settlement included provisions that Faust be restored or where his time accruals were used, such accruals would be restored to the District payroll from the time of termination and that the District might proffer charges against Faust pursuant to Section 75 of the Civil Service Law and whereas the commissioners in 2018 had investigated the basis for termination and had found probable cause for termination, and whereas the commissioners have directed counsel to review the basis for termination and, as appropriate, prepare charges against Faust, counsel for the District having reported to the Board, thereon, be it resolved that the Board of Commissioners hereby finds that probable cause exists for the termination of General Supervisor Faust, and authorizes the issuance of charges against Faust, which charges and facts are incorporated by reference, herein. Further, it is resolved that the Commissioners hereby designate the Honorable Ira Warshawsky, of the law firm of Meyer, Suozzi, English & Klein, P.C. as the hearing officer to hear the said charges and it is further resolved that Daniel Faust is directed to appear before

the District's counsel or designee for questioning before the hearing at a time mutually agreed upon with the District's counsel. Aside, such questioning will be done on the record, and Mr. Faust will be permitted to have counsel, or his labor representative present at the time of questioning. Dated January 27, 2021.

MOTION

On Motion by Commissioner Samoles to approve the resolution, Commissioner Hemsley seconded the motion, and it was unanimously approved. Motion passed.

Commissioner Samoles stated:

It is hereby moved that the Board of Commissioners terminate the employment of Jacqueline Urli as the District Secretary to the Board, and it is further moved that the Board of Commissioners hereby directs Jackie Urli to turn over to the Chairman all keys in her possession, for anything related to the Sanitation District. And it is further moved the Board of Commissioners directs Jacqueline Urli to turn over to the Chairman all property of the District in her possession within twenty-four hours. And it is further moved that the Board of Commissioners hereby directs Jacqueline Urli to turn over to the Board, by email, all passwords and usernames for all matters related to the District. It is further moved that the Board of Commissioners hereby directs that Jacqueline Urli be and is hereby banned from District property, except for public meetings, and it is further moved that the Board of Commissioners hereby directs a supervisor and a maintenance worker, working on Friday, January 8, 2021, to secure and pack Jacqueline Urli's personal objects to the District's offices and the maintenance employee is authorized and directed to deliver same to Ms. Urli's house on Friday, January 8, 2021. And it is further moved that the Chairman is hereby authorized to file within the Nassau County Civil Service Commission, a CS-39, informing the Nassau County Commission that Jacqueline Urli has been terminated. And it is further moved that the District's office staff is directed to provide Jacqueline Urli with Cobra notice relating to her health benefits, and to file with NYSHIP that, effective February 1, 2021, Ms. Urli will no longer be on District health insurance. And it is further moved that Jacqueline Urli shall be paid through January 31, 2021 and it is finally moved that the District treasurer shall, upon consulting with the counsel to the Board, calculate and report to the Board of Commissioners on any payments which may be due to Jacqueline Urli, upon her termination.

MOTION

On Motion brought by Commissioner Samoles to terminate Jacqueline Urli, Commissioner Mannone seconded the motion, and it was approved by Commissioners Graff, Mannone, and Samoles. Commissioners Doherty and Hemsley voted against the motion. Motion passed.
