Public Comments:

Commissioner Doherty asked the public do we need to have the YouTube videos going on every meeting. If it is vital? Is it important to everyone?

Mr. Faust stated why would you not want it?

Commissioner Doherty replies Well, I mean, if we take minutes and report.

Mr. Faust interrupts that have not been *inaudible* for months.

Commissioner Doherty asks Is that a fact? Where are the minutes at this point and time? Because, I mean, bottom line is this, look, we never used to

have to use a YouTube for meetings. I guess, Joe, you were chairman for eight years. I mean, but the bottom line is so in the past, it was read the minutes each month, but have them up in time every time so you could read them in its correct.

Unidentified speakers stated I think that what you've done with YouTube before and then has a that we want to make it more transparent and more transparent. And we've kept it now for the more transparent meetings.

Commissioner Doherty states I guess when you guys were prior to my first term in here, the meetings used to be in the morning. My opposition to that was most people are working. So, it was let's do it at night. So, everybody's available. I guess it's 50/50, so. Okay, I'll just move on from there.

Commissioner Mannone states I think the YouTube and moving us to the thing is all about the transparency that that the wave the change that has come to our community. And like Michael over here says, they put stuff on YouTube, too. And it's just, you know, I mean, we've had you know, it gives more exposure to the public and they can look at what we're doing and get their draw their own opinions.

Commissioner Doherty asks Mike D'Ambrosio Sr. asks as a school board member how do you guys handle the interactions as far as public comments go?

Mr. D'Ambrosio replies at the end we open for questions. We have two mics like set up on both aisles. You can come out in your allowed 3 minutes, if there's a question, the answer is we hold up on the minutes in case there's any other questions. That is the goal is a three-minute statement. And if we can answer that, we answer it. If not, then what we do is get back to that person involved.

Commissioner Doherty asks So the 3 minutes include questions and answers from an individual?

Mr. D'Ambrosio replies if we can give an answer that compliments questions and we just back to them, we have that. If we have those answers right now, you tell them to get back. 3 minutes with the public to come up and make a statement regardless of whatever gives us.

Commissioner Doherty states t's not I'm not saying this only from one side to the other side. I'm saying from both sides. I don't you know, I'm seeing an awful lot of back and forth that I don't; I don't know, maybe I'm doing it the wrong way here.

Mr. D'Ambrosio states that the board moves on an agenda. Then we had some folks there that we like to speak about. Plenty of them in action. All right. Those people can express those things that we vote on. at the end of the meeting, it's a community or a public thing. They can say what they want to do.

Mr. Faust states most of them support a limit on how many.

Commissioner Doherty stated I've got to be honest with you guys, and we've been here a long time. I just don't I'm a very non-confrontational person, and I don't like the back and forth that I understand where it comes from, from both sides. All right. But I just don't want anything to ever get to the point where it gets carried away. And if we can follow rules of order and be civil about it and really get to understand why the questions are there, I mean, we're talking about foils. I mean, last week, look, I'm sure that's there, but that's your right as the public.

Mr. Cibellis state how do you make a statement like that when you know my questions have gone on for years. So, we'll just start with the simple question like a foil if that was the school board, for example, that foil would have been provided.

Commissioner Doherty replied well, there should be an answer.

Mr. Cibellis states comparing this to the school board is frustrating to him.

Commissioner Doherty states Joe, I'm not fighting with you. What I'm saying is, is that when you ask the question, we better have an answer to the next meeting. I understand that you've been waiting, and we all do, right? I mean, everybody here must raise their hand and say flat out, we've been waiting for these foil answers.

Mr. Faust states I know you concerned that it could get out of hand. The only time it really got out of hand was when someone invited by one of the commissioners with the understanding of that process is now in the state came here.

Commissioner Doherty stated Well, that's part of why I am stating what I'm saying. Look, I'm not pointing fingers in either direction here. I'm trying to make...

Mr. Cibellis interrupts your elected official, this course, there's thousands of Robert's rules you have your own bylaws. Before you make a statement like that, you need to follow those rules. Then you understand why this is a lot of back and forth. So, it is both sides, but I won't deny it.

Commissioner Doherty asks but is there a Roberts rule in a school board as well?

Mr. Cibellis replies Yes, and they would file it there would never be a foil in the school board that would sit for years.

Commissioner Doherty asks So what are we doing wrong?

Mr. Cibellis replies I do not want to go there. You have enough questions to know.

Commissioner Doherty states What are we doing wrong? That's not getting answers done that take that long. I want answers just like everybody else does.

Commissioner Graff states with respect to YouTube, I think it's very important that people can see what our meaning is and that it's preserved and it's there forever. In respect to the back and forth. And one thing I want to say is the budget meeting that we had that was repeatedly used against me in the recent election. That was the purpose of the of the YouTube for that was so that everyone could see what goes on in a budget meeting, unlike what happens in school board, unlike what happens in this library, unlike what happens at fire. And with respect to the foil. I don't want to call you out, John Ciampoli, but I'm going to have to. I've asked. I've asked for it to be done.

Commissioner Doherty states we must do to satisfy freedom of information law

Mr. D'Ambrosio states that our school board budget meetings are open to the public.

Commissioner Graff replies No Mike, your budget hearings are open, but the creation of the budget is what was on YouTube. Literally the creation of the budget.

Mr. D'Ambrosio states *inaudible*

Commissioner Doherty states this not what a school board and I'm sorry for bringing it up in the first place. I mean, I value your opinion about how you do board, the school board, there is no conflict because they do not interact with the public, because if you've ever watched our YouTube videos over the last year, it's horrible.

Commissioner Mannone replies It's also entertaining.

Commissioner Doherty replies no its not. It's not entertaining for me; I tell you that.

Commissioner Mannone states It's not for us. It's painful for us.

Commissioner Doherty states its very painful for me

Commissioner Mannone states but it is very entertaining for the public.

Mr. Faust states *inaudible* members of the board, and that is why people are here.

Commissioner Doherty states I know, listen I'm sorry Austin.

Commissioner Graff replies No, you're a commissioner. You should raise whatever.

Commissioner Doherty states What we should be doing is discussing and not standing and yelling. I mean.

Mr. Cibellis states it's simple. There are rules, I've been criticized for years. Like you saw for their rules. I made some mistakes. You guys make a lot of mistakes. I don't criticize. I hate it. There's a thousand ways you could do it. I can guarantee you. I never had the lawsuits at the courthouse right now, and I never had several people sitting in the front row with the same question. By law, these things should be answered. They're not.

Commissioner Doherty replies Yes, I understand that very clearly. Do you think I'm really trying to divide things? Right. Look, I hate the division that we have, and I really do.

Mr. Cibellis states to assemble the division.

Mr. Faust states I was in the public forum for many years and not every meeting I went to was long in question. And it's the nature of the beast you get in the public world now you better expect it.

Commissioner Doherty replies And I've got to tell you Herb, every time you've ever spoken, I've always respected everything you've had to say. And look at not I'm not trying to blow smoke up anybody or anything else, but it's just it's getting to the point where, we know what we must deal with, right? Bottom line, we must answer foils. How do we do this? Austin.

Commissioner Mannone states that he has a question for John Ciampoli. He asks, have we denied his foil?

Mr. Ciampoli replies I have told him I have attempted to contact Mr. Cohen, who was his attorney on the last coil. There is still an outstanding appeal. When I get a response from his attorney.

Mr. Cibellis states it's been years, years it's been. And my foil is a personal foil for me. The other foil is from the attorney doing it on my behalf. It's not my foil.

Commissioner Mannone states I'm not arguing with him. I got questions for him. I want to understand this.

Commissioner Graff states quiets guys. One at a time.

Commissioner Doherty states make it a conversation.

Mr. Cibellis states if I'm yelling, I know I don't have a microphone and I know that the people listening can barely hear me. You what to put a microphone on me we can stand up.

Commissioner Doherty states I can hear you clearly.

Commissioner Mannone states You're not Joe. You're not yelling. You're just speaking loudly. But, John, so here's the thing. Is the district position, are we objecting to it? Because under his attorney, who's who as his attorney, is acting on his behalf, made that foil and hasn't paid.

Mr. Ciampoli replies has not paid the balance that was due on the foil.

Commissioner Mannone asks does he, have it?

Mr. Cibellis stated two meetings ago they said they give it to him

Commissioner Mannone states so bill him.

Mr. Ciampoli stated yes, we did.

Commissioner Mannone asks through his attorney?

Commissioner Mannone asks You got a problem with paying the invoice for the documents?

Mr. Cibellis replies it's not my invoice it goes to Steve Cohen.

Commissioner Graff replies I got to respond to that. Because here's the thing. If an attorney is doing an investigation on your behalf, he's an agent of you. You are the principal. The agent owes the money and so does the principal. So, if he was doing an investigation on your behalf, which is what you just said, he is your attorney.

Commissioner Mannone asks you have a problem. Did you have a fight with him?

Mr. Ciampoli states he was your attorney for that foil. That foil has not been paid for. Therefore, you have not paid for it.

Mr. Cibellis stated I didn't not say he represented me, because the foil came on my behalf. I got to be honest with you. I had nothing to do with it. It was something you was taking care of. You know it. I know it. You said you reached out to incident. Several times. I've been to these meetings and every board member has said, why don't you get the foils and I got to be honest with you Because it's on YouTube. And this is why when you look back at the other meetings, they throw you under the bus and told you to give me the foils. I'm not the only foil that has gone unanswered for over a year. The last time I was here there was another gentleman who says he's had a foil that has been unanswered for over a year. Are you going to acknowledge that?

Mr. Ciampoli responds Allow me to complete your sentence. Your attorney did a foil on your behalf. That's the part of the sentence that you keep leaving out. That foil was not paid for, unless there is a vote by the board to say..

Mr. Cibellis asks Then why don't you give over the documents?

Commissioner Doherty asks So John's waiting for payment from you or your attorney?

Commissioner Graff replies Yes.

Mr. Ciampoli states on a huge foil.

Commissioner Mannone ask how much money is owed?

Mr. Ciampoli replies, its over \$1,000

Commissioner Mannone states So you've got a \$1,000 bill, because you made us make a huge amount for copies or your attorney made us make a whole bunch of copies for this information. Now, you want this?

Mr. Ciampoli states the last communication I had, Joe.

Mr. Cibellis states first, the whole conversation had nothing to do with it. There was a bill. according to him, he paid the bill after he received the documents and paid the bill.

Commissioner Doherty asks your lawyer?

Mr. Cibellis replies, my lawyer, Speaker2: said it was done. There was no way you would have gotten the documents without paying the bill. So, I don't even want to go there.

Commissioner Doherty asks So why didn't they give them to you?

Commissioner Mannone replies So you're saying. You're saying what's paid off? You're all paid up. Everything's gone. And this is the brand-new foil.

Commissioner Graff states Here's what we're going to do. Can I have a motion to approve releasing Joseph Cibellis' foil without payment of the prior foil? I'm making the motion so that there's not an issue about payment.

Commissioner Mannone ask but is there an issue of payment or not?

Commissioner Graff replies there is an issue.

Mr. Ciampoli replies there is an issue of payment. We ask for it. We ask for, I believe it was \$1,500 up front.

Commissioner Mannone asks and what happened?

Mr. Ciampoli replies We got the \$1,500 up front to be billed against that the 25 cent per page statutory amount. it came out to about double the \$1,500

Commissioner Graff states Can I have a second on the motion? And the one seconding the motion not to not to hold for the payment.

Commissioner Doherty replies Yes.

Commissions Graff states you made the motion.

Commissioner Doherty state the motion is to satisfy the foil that was requested two years ago. I am all for it.

Commissioner Mannone states the counsel saying that there's a 1500 outstanding bill above what his attorney paid.

Commissioner Doherty asks who gets the 1500 dollars?

Commissioner Graff replies We do.

Commissioner Doherty states the district. just to satisfy everything. I don't know. I would second the motion Austin just made.

Commissioner Mannone asks John, you're saying he owes 1500, but just to get rid of this

Mr. Ciampoli replies I'm saying he owes over \$1,000.

Commissioner Mannone asks Ok over 1000 dollars. Do we just want to settle to forget and just forget the \$1,000?

Commissioner Graff replies forget the number, yes.

Commissioner Mannone asks If we settle it, can we get him the balance of the file? And is there a fee on that one?

Mr. Cibellis states they are completely different points. I have no idea what Steve Cohen could have foiled. Not one idea. I asked for you guys who you've discussed it back and forth.

Mr. Ciampoli replies There's going to be a fee on that one.

Commissioner Graff states We'll figure that out after we just get the documents together.

Commissioner Doherty states you shouldn't be here every month looking at the answers that you asked.

Commissioner Mannone states I want to make sure that if we give him this thousand, just let it slide and just say forget about it.

Commissioner Graff state to get him the foil, we are waiving the fee for the first one just to get him the foil.

Commissioner Mannone states I'm kind of okay to get rid of this.

Commissioner Graff asks Can I have a motion?

Commissioner Mannone states I'll second the motion. But before we get to the vote, I just want to get some things so this way he gets his foil. If we send it to him electronically, does that avoid the fee?

Mr. Ciampoli states if we don't have to create the electronic files to send it.

MOTION

On Motion by Commissioner Doherty seconded by Commissioner Mannone to waive the fee for the foils so Joseph Cibellis can receive the documents. Unanimously approved, 4-0. Motion passed.

Commissioner Hemsley states I just want to go on the record real quick. For yesterday, I came at about 1:07 p.m. to check petitions because it's election season. Speaker3: looked at the petitions that were handed in for the election this year. I look to see who turned it in. Apparently, there's two different Cheryl's. Looks like two different people. Anyway, on the petitions. So, there's two different names on the petitions. Neither one of them has enough signatures on either paper, so I don't know if it's two people running or one. Signatures don't look right. It's not really filled out correctly. No addresses for the candidate. Mannone was a witness on one of them. Didn't fill out the number he witnessed signatures on. Let legal counsel know yesterday, and I guess I'm waiting on Board of Elections for a final answer. That's all I got. Commissioner Doherty states so what you are saying there are two different names.

Commissioner Hemsley states I don't know. Speaker3: here's one name on it, and then there's a different name on another piece of paper. There's no address. There's not much. There are three sheets with a total of 29 signatures.

Mr. Ciampoli states what we need to do is have a procedure for the board to move forward.

Commissioner Hemsley asks Yeah, that was a that was another thing. Who picked them up?

Mr. Ciampoli states the secretary of the board is the chief elections official in the district. Therefore, it would, in my opinion, devolving upon the board commissioners.

Commissioner Mannone asks so he expanded in the past elections?

Mr. Ciampoli replies correct.

Commissioner Doherty asks how many petitions have been handed in?

Commissioner Hemsley replies, mine and whatever is going on over here.

Commissioner Mannone states *inaudible* in a desperate attempt.

Commissioner Hemsley replies, John, I know you like playing the game anyway, since your name is on the bottom of the petition. So, we already know. I just. I also just while you're while you're talking about it, since your name is on them, I just I want to know who picked them up. Who picked them up for and nobody signed for them? Nothing on the sheet that you're supposed to sign to get your petition. Do you know anything about that?

Mr. Ciampoli states there is no sheet.

Commissioner Hemsley states There is a sheet. I have it right here. No, no, no. I have a sheet right here and I got a time stamp and the whole thing. I have the sheet tray here. I have the sheet.

Commissioner Doherty states something about the petitions, the microphone is too far to pick up the audio clearly.

Mr. Ciampoli states That there was filed within the time frame. Implicating that there was a typographical well on the petition

Inaudible decision between Mr. Ciampoli and Commissioner Doherty.

Mr. Ciampoli states we have not had objections before on petitions. So, this board should discuss in executive session what they want to do.

Commissioner Doherty states not necessarily what we want, but what is in play.

Mr. Ciampoli states well that part of what is in place. You could tell me who the secretary to the board is. Then that person gets to make the decision, but there is no person in that position.

Commissioner Doherty ask So then that resides on the board?

Mr. Ciampoli replies yes. In my opinion that devolves to anything delegated to administrative.

Commissioner Doherty states I don't want to do something that's illegal.

Mr. Cibellis states I'm sorry but can you just because we're no longer thinking that we don't know what's going on. Can you tell us exactly what that means in English?

Commissioner Graff ask what? What means?

Mr. Cibellis states Everything that just happened.

Commissioner Graff states Here's what happened. And I will explain it. I will explain it. Yesterday at 1:00 was the deadline to file petitions for the election. That's coming June 16th. Ryan put in petitions along with one other person, the petitions by that other person. Ryan is raising objections to the petition that that person should not be on the ballot.

Commissioner Doherty ask Did it have 25 signatures on it?

Mr. Ciampoli states there are 25 signatures on that person's petition sheet.

Commissioner Doherty asks Is that person real?

Mr. Ciampoli replies Yes.

Commissioner Doherty ask do we know his real name?

Mr. Ciampoli state we have a communication from that person saying there was a typographical error on the petitions that were filed. It was filed about an hour or so before approximately an hour before the deadline to file petition.

Mr. Cibellis states So you are going to need about an hour before what Ryan is concerned with.

Mr. Ciampoli states it addresses one concern. And just say you want to know because I know what you're looking to do here. So, for your YouTube, your audience, sir, I informed Ryan how to do the objections. I have conducted myself impartially throughout this process.

Mr. Cibellis states I'm not trying to do anything, just asking a question for every taxpayer.

Commissioner Graff states So then what John Ciampoli is saying because we don't have anyone sitting in secretary to the board because our bylaws called that person the chair of the election. Chief of election, or whatever the title is. The decision is now made by the commissioners because there is no secretary to the board.

Commissioner Doherty ask so you're saying to me that our previous clerk had the authority to make that decision.

Commissioner Graff replies Yes, she could have if she wanted to.

Mr. Ciampoli Just as you do, in a village election, just as you vote accepting, you've got to accept everything that comes across the counter. Here, the question has been raised as to the validity of the petition that was filed that in a village setting is the duty of the village clerk. In other election settings, there is an election official and in the general. Election, that's the Board of Elections.

Commissioner Doherty asks Can I just one more time? We have three different petitions.

Commissioner Graff replies you have two petitions.

Commissioner Doherty asks two petitions with different names? How different?

Commissioner Hemsley replies Completely different.

Mr. Ciampoli states your hitting on exactly the point. The point here is we have two sets of petitions. We have a communication from the person who is named on one set of petitions. Saying there was a typographical error.

Commissioner Doherty states on those two.

Mr. Ciampoli states Now it is up to the Chief Elections Official. Of this district to determine whether that email is a sufficient cure.

Commissioner Doherty asks So we need to look at that document as a board?

Mr. Ciampoli replies as a board. Because there is no secretary to the board. So therefore, it's got to go to the Commissioners.

Commissioner Doherty asks what about the other set?

Commissioner Graff replies the other set is Ryan.

Mr. Ciampoli states and there are no objections to Ryan's positions.

Commissioner Doherty states So let's take it into executive session, look at it, come up with a decision.

Commissioner Graff states the reason why we're going into executive sessions to obtain legal advice, not make a decision.

Commissioner Mannone states we can discuss the legal advice.

Mr. Dan Faust asks *inaudible* in witnessing this petition?

Mr. Ciampoli replies one of the commissioners is the objector.

Mr. Dan Faust asks but shouldn't that commissioner *inaudible*

Mr. Ciampoli replies I think I know what you're going down. I will give legal advice to the board when they're in executive session.

Mr. Faust asks who made the typographical error?

Mr. Ciampoli replies, it really doesn't matter. Whoever prepared the petition.

Mr. Faust asks is it by someone here or the person running?

Mr. Ciampoli replies it's in the name of the candidate. That is something that is filled in by the candidate or the candidate's agents.

Mr. Faust asks that's with the typographical error. Now is it on the person running not to make a typographical error?

Mr. Ciampoli replies You know something, 20 years ago the case law would have said, you are absolutely right, that's a bad petition. However, today you're absolutely wrong. That is a good petition. If it is cure, if it is sufficiently cured.

Mrs. Urli asks what time did email come in?

Commissioner Mannone asks you are going to give an exact date and time?

Mr. Ciampoli replies Yeah, I'm fine with that. So, you know, the email was dated Wednesday, June 1st, 2022, at 12:21 p.m. Eastern Daylight time. June 1st, the deadline was 1:00 pm. Okay, I'll read you the text of it. I have been informed that there was a typographical error. My name should appear as Sheryl Beckman Mednick on the ballot for the election. Please note there was no confusion caused by this misspelling when the petition was circulated. Thank you. Signed Cheryl Beckman Mednick sent from my iPhone.

Commissioner Doherty states Look, if it's a letter or two because two people did different things, I can understand that.

Mr. Ciampoli states There are things, that are in the objections. The important thing that you need to realize here is that this board needs to have a policy.

Commissioner Hemsley states the first candidate's name on the first sheet, it says Sheryl Decland Chabef. On the second one it says Sheryl Beckman Mednick. It only has 5 signatures. It's a completely different name.

Mr. Cibellis asks how many are there? Two or three?

Commissioner Hemsley replies there is three sheets.

Commissioner Mannone asks how many names?

I have the floor. I have. That's my priority. I'm a citizen. I'm an elected official. And the Mister has posted Swastikas. And, yes, she did. And I'm opposed to you.

Commissioner Hemsley states this is your fault. Take responsibility for your actions.

Commissioner Mannone states listen, a typographical error is not equal to a swastika. I have the floor. You guys are interfering. I am speaking and I expect the respect.

Mr. Cibellis states You got to give respect.






