The Fall children's and senior's programming began in September, with the children's programming being the busiest in the history of the Library. The School Division has provided financial support for this literacy and learning program to allow the Library to hire an assistant. The Seniors Program averages 30 attendees a week. The new coordinator has been working hard to increase this program's success. The STEM Lego Program has been expanded to four library teams.
