REQUIREMENTS

PRE -REQUISTIES

You must be at least 18 years old.
A US citizen or legal resident.
Possess a valid driver's license.
Be eligible to enter a CDL program.
Pass a Medical Physical
Pass a DOT drug screen.
Have no conflicts that would prevent you from attending all scheduled hours.

Entry Level Driver Training

CDL Requirements

driver's license, you'll need to get a commercial learner's permit (CLP). Our first week of class will prepare you to take the required test to earn your commercial learners permit. Once you have completed the classroom training you can schedule an appointment with your local Department of Motor Vehicle office to take the permit tests. There are items you will be required to bring with to qualify for a South Carolina commercial driver's license, you'll need:

Before you can get your commercial

Proof of Identity - You can use any of the following documents to prove your identity in South Carolina:

- Birth certificate.
- Valid U.S. passport.
- Certificate of Naturalization.
- Certificate of Citizenship.

If the name in the above documents doesn't match your current one, due to marriage, divorce, or any other reason, you'll also need to bring in the legal documentation proving that your name has been changed.

Proof of Social Security Number

Bring any of the following to the SC DMV to prove your Social Security number (SSN):

- Social Security card.
- Current military identification card.
- Tax forms or payroll stubs that include your SSN.
- Medicare card.
- Letter from the Social Security Administration.



CDL Medical Requirements

To be eligible for a CDL in South Carolina, you'll have to prove your physical fitness to the Department of Motor Vehicles.

- Be at least 18 years old.
- Applicants under 21 years old will be restricted to driving within South Carolina only—referred to as intrastate driving.
- Have a valid, non-CDL driver's license from South Carolina.
- SC auto insurance on your vehicle.

Medical requirements

Passing the CDL medical exam is a mandatory step for commercial license applicants in the United States, as drivers must prove they are physically and mentally fit to operate a commercial vehicle. If you successfully meet the CDL physical exam requirements, you will receive a medical examiner's (ME) certificate of a limited validity, which must be maintained on your driving record on a regular basis.

The CDL physical test must be conducted by a qualified medical examiner listed on the FMCSA National Registry. DOT physical exams are generally administered by approved Doctor of Medicine, physician assistants, Doctor of Chiropractic, advanced practice nurses and Doctors of Osteopathy.

Even if the CDL physical test is typically administered on a 24-month basis, certain drivers may still be required to retake the exam on a more frequent basis if they have a condition that must be monitored regularly. Note that, if you fail to pass the CDL physical exam on time, you will be prohibited from operating a commercial vehicle until you recertify.
