Barn and Safety Rules

We have some of these rules because the insurance company requires them. Some are because good citizenship implies them. Some just make good sense. All of them make life at Northern Arizona Riding Stables safer and more pleasant.

The Facilities

- ❖ **NO SMOKING** is permitted anywhere in or around the barn except in the motor vehicle of the smoker.
- ❖ **NO RUNNING OR SCREAMING** around the horses.
- ❖ Children must be supervised at all times.
- ❖ **Dogs not owned by employees MUST be on leash** and under the supervision of their handler.
 - **Be considerate of others.** Don't allow your dog to annoy others and their horses.
- ❖ **NO FREELANCE INSTRUCTORS.** Outside riding instructors and trainers are subject to a Facility Fee per hour per horse and/or rider. All outside instructors must work through Northern Arizona Riding Stables management and are required to provide proof of liability insurance coverage with Northern Arizona Riding Stable specifically named as additional insured.
- ❖ **YOU MAY NOT GIVE LESSONS** on your horse or the horse of another and/or offer training for a fee unless you are an approved trainer of the facility.
- ❖ **PARK ONLY** in designated parking areas.
- ❖ **YOU ARE RESPONSIBLE** for your guest's actions and safety. **All guests** are required to sign a Liability Waiver and are expected to follow all rules of Northern Arizona Riding Stables
- ❖ **MAKE SURE** that all doors, gates, latches, and locks are properly secured before leaving the premises.

The Barn

- ❖ **BE RESPECTFUL** of others. This is a shared space!
- ❖ **DO NOT** borrow tack or barn supplies unless you have permission.
- ❖ **BE AWARE** of your surroundings and any influences that could impose upon the safety of you, your horse, or others.
- ❖ **HORSES MUST** be washed in designated washing areas. Water hoses should be recoiled and **water turned off** when you are finished.

- ❖ **DO NOT** leave your grooming supplies, tack, and equipment lying around.
- ❖ **DO NOT** drive screws, nails, hooks, etc., in doors or walls or anything else at Northern Arizona Riding Stables. If you need to have something attached, our **Barn Director** will attend to it.
- ❖ **REPORT** any need for repairs to management.

The Horses

- ❖ A facility use fee and proof of **negative** Coggins test is **required** of visiting horses prior to unloading on the premises.
- ❖ Cribbers **must** wear collars or cribbing straps.
- ❖ Kickers and biters **must be marked** on the Stall Card and will **NOT** be tolerated long term.
- ❖ Horses are **required** to be kept up to date on vaccines, farrier, deworming and general care.
- ❖ **EACH HORSE IS REQUIRED** to have a well-fitting halter **with an attached leadrope**, in good condition at their stall – **at all times**.
- ❖ **YOU ARE RESPONSIBLE FOR THE CARE OF YOUR HORSE** while you are on the premises. **Clean up after yourself and your horse.** Pick up poop and sweep up hair, hay, hoof dirt, etc. in the wash rack or aisle.
- ❖ **ANY CHANGES** you need to your horse's feed schedule must be communicated through the **Barn Director** to assure accuracy, **please do not** instruct the workers.
- ❖ **DO NOT FEED** any horses without horse owners' permission.
- ❖ **NO** ground tying.
- ❖ **ALWAYS** practice safe horsemanship.

Riding and the Arenas

- ❖ **NO ONE** may ride or handle horses on the premises **without** signing the "Northern Arizona Riding Stables Liability Waiver".
- ❖ **ALL RIDERS UNDER THE AGE OF 16** must be supervised while riding.
- ❖ **APPROVED ASTM HELMETS ARE REQUIRED** for riders under the age of 18 and **anyone** using the jumps.
- ❖ **ARENA PRIORITY** will be: Booked Events, Lessons, General Riding, Lunging, Turnout
- ❖ Most importantly **HAVE FUN!**
