#### **OLD BUSINESS**

Meeting was called to order at 1:03 pm by Chairman Marv Grassl; Board Members present were Terry Utecht, Bill Middleton, and Paul Herrman. Guests included Bob Koch; Commissioner and Tim Waters; WSU. Minutes from the January 19, 2016 Board Meeting were reviewed and approved with a motion from Paul Herrman and a second by Terry Utecht. Motion passed.

Monthly Financial – Review of the January Treasurers Report, P&L comparison 2015-2016 and Budget update Meetings & Events attended – Basin Bloomers Garden Club Jan 20, Betsy; Columbia County Grower Meeting Jan 28, Staff was invited to participate in the event. 6 recertification credits for full day attendance. #### **NEW BUSINESS**

**County Rd** – Todd reported the revocable, non-expiring Interlocal Agreement between FCWB and FC Public Works for roadside spray program has been submitted to the Commissioners for review and approval. Conversion of the 2001 Freightliner to a water delivery truck is complete; however, there appears to be a problem with the automatic shift transmission that needs fixing. Todd and staff have been working on refurbishing Spray truck 4 to remove rust. Spring residual tentatively set to resume the week of the 22<sup>nd</sup>.

**WA State Parks** – A proposal for 2016 work on the Columbia Plateau Trail has been sent to Andrew Fielding; Resource Steward, East & Northwest region. Todd advised an Interlocal Agreement or some type of written contract would be advisable specifying the scope of work.

**FCWB** – We have been informed by Corwin Ford that the delivery of the new Ford F-250 has been pushed back. Construction of the pickup is scheduled to begin mid-February with completion and delivery in mid-March.

**Expiring Board Member March 1, 2016 – Dave, Paul**- Potential candidates for District 2 Director were discussed. Discussion on narrowing down the list and sending out informational letters followed.

**Vice Chair Position**- Motion by Marv Grassl with a second by Bill Middleton to appoint Terry Utecht as Vice Chair. Motion passed.

Weed District - Formation of a Weed District as an alternate option to current county status was discussed.
