Efforts being made to conduct structure fire training with Wing Alabama FD. Goal date is 23 April 2022.

Efforts to include Bradley FD in structure fire training is being made as well.

Annual truck pump testing is scheduled for 3<sup>rd</sup> week of May 2022. Tests are to be made by SunBelt at a cost of \$538. Motion was made and approved for this testing to be accomplished.

Fire House Sub gran has been disapproved once again.

AFG grant for 10% matching funds for new fire engine should be approved/disapproved sometime in July 2022.

Work for a 50/50 grant for 6 sets of irons (glorified crow bars) and 6 air packs is being drawn up. Three quotes for cost of items will be presented at the May 2022 meeting.

A request for tee shirts for 3 each for a total of 60 shirts at a cost of approximately \$1200. Three quotes to be presented at the May 2022 meeting.

Dues(\$300) for Chiefs Association are due. Check will be given to Chief Bingham at May 2022 meeting.
