Justice Episteme Ltd has developed an application, Environs, which can consolidate and map publicly available data to a variety of boundaries, to create a holistic picture of individual area statistics. Environs has been used to identify for each region in England, the Lower Super Output Areas ('LSOAs') that have the highest levels of crime.

*Disclaimer - This analysis is a non-exhaustive; and does not seek to draw any conclusions about the LSOAs identified. Rather, the intention of this analysis is to demonstrate the functionality of the Environs application and that users have a powerful tool at their disposal for consolidating and interrogating data, which can direct their research, allow them to form hypotheses and support subsequent evidenced backed conclusions from the data.*

# The Challenge

- Organisations need coherent data about demand, performance and outcomes.
- A wide range of information is available. Government publishes tons of it!
- **BUT** not usually in a form that can be easily joined together, key features understood, and from which specific and general points can emerge, and comparisons possible. It is in silos
- Wide geographical variation means we need to understand distributions.

Tails of distributions pick out problem areas or exceptional results.

Averages -> inadequate problem analysis -> poor performance

- Socio-economic indicators and other data published in different form, cover different geographies etc. Can achieve better picture by integrating using a common base.
- Want to be able to explore, to breakdown silos:
  - Look at a variety of metrics individually and together.
  - Identify distributions (joint distributions) and pick out top/bottom % (high/low service availability; good/poor performance).
  - Compare – areas, metrics etc.
  - Export selected data/analysis for use elsewhere.

# Also A Word About the *glue* ...UK Geography

- Super Output Areas are an ONS geographic hierarchy designed to improve the reporting of small-area statistics. (>200,000) – data most often published at higher levels as below:
- The Lower Super Output Areas and Data Zones list contains 42,619 areas of the following constituent geographies:
  - 32,844 [Lower Super Output Areas](#) in England.
  - 890 [Super Output Areas](#) in Northern Ireland.
  - 6,976 [Data Zones](#) in Scotland.
  - 1,909 [Lower Super Output Areas](#) in Wales.
  - Other Data reported at LA, PFA, CCG, Region, CSP, ....

*And sometimes we will want to define our own depending on the problem.*

- Environs Mapping algorithms can be flexible, joining up datasets at the possible geographical level.
- We also plan to accommodate census 2021 data.

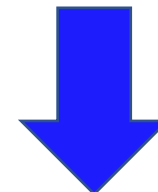

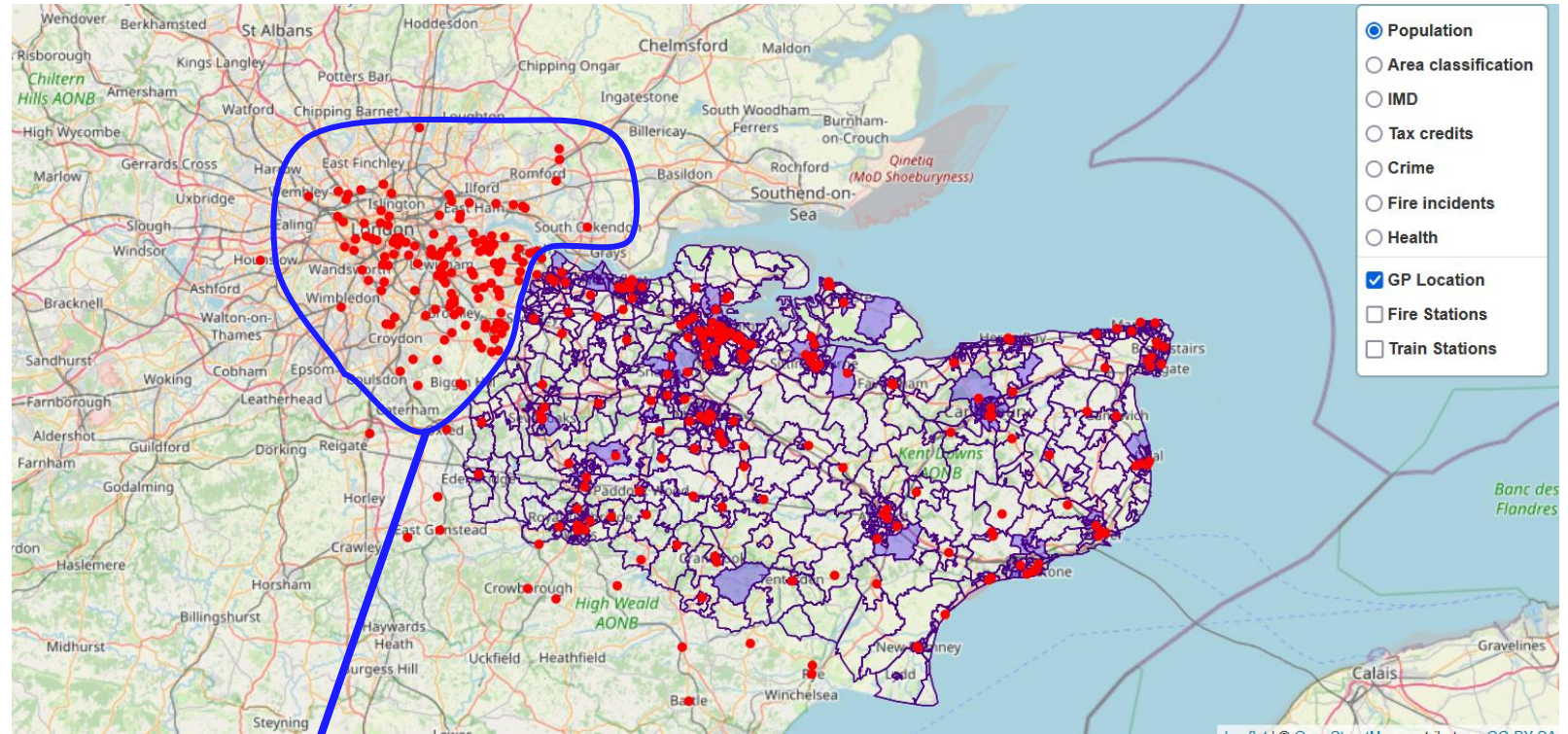

# Example: Health services

- The NHS is facing unprecedented challenges.
- How can we use health data to explore how people access services, e.g. GP services?
- Chart shows where people are registered with a GP.
- Daily commute means that a substantial fraction of residents in Kent have their GP in London.
- Other possibilities: use GP prescription data to characterise health need in communities.



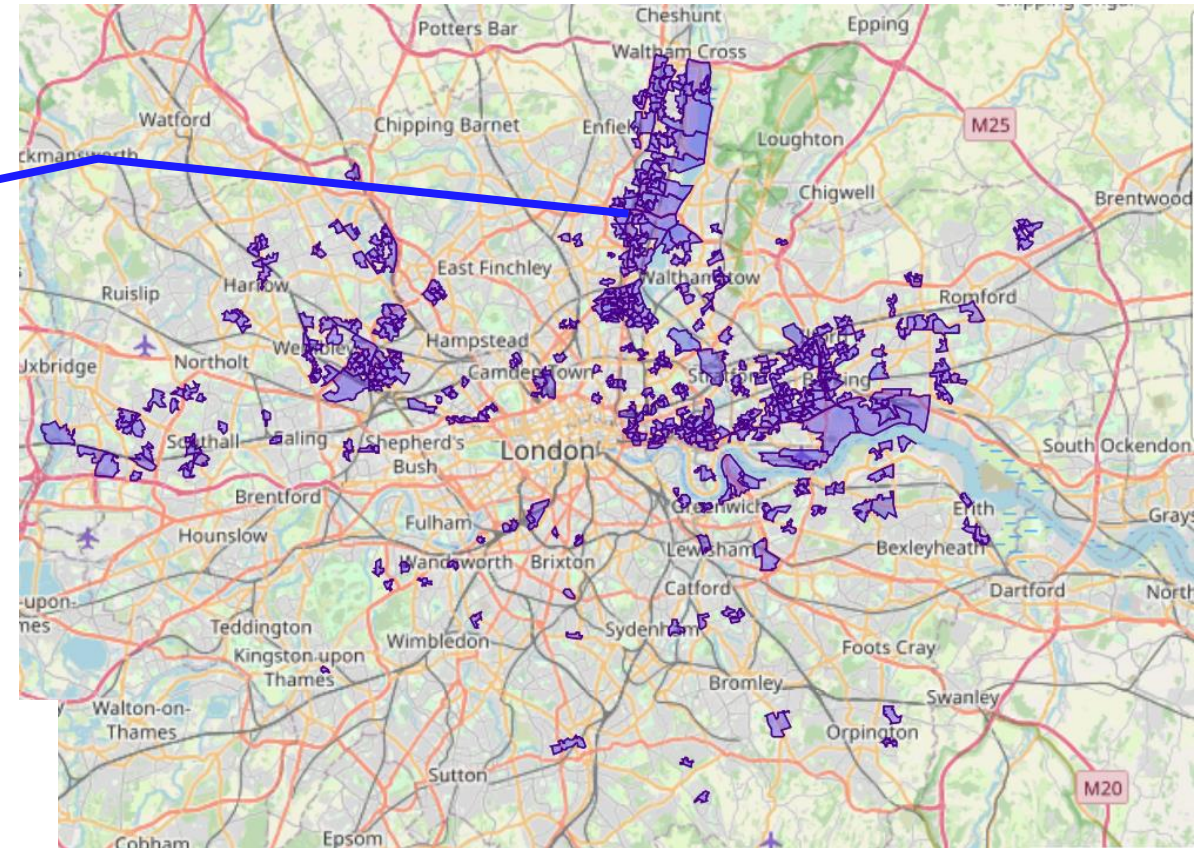
~47% of GP practices used by people living in Kent are out-of- area

# Example: Children in Need in London - Tax credits

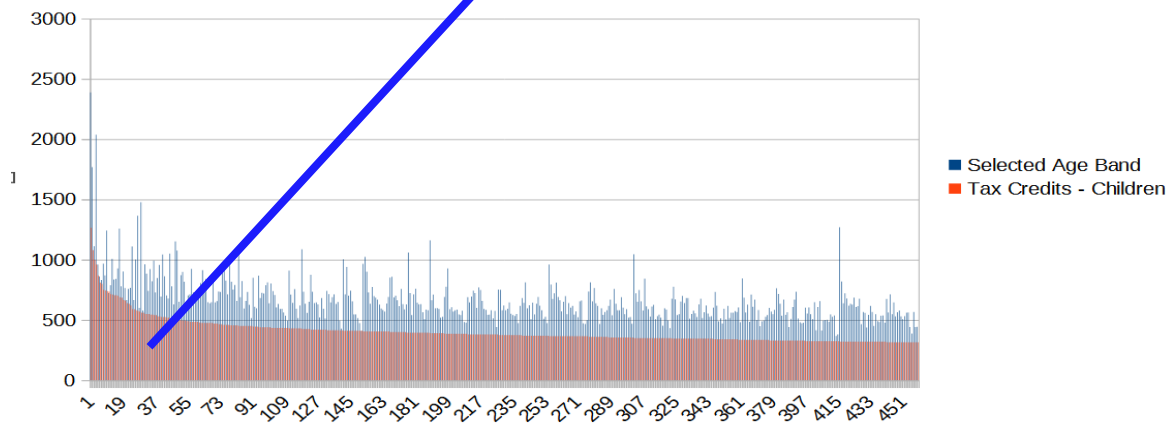
- Information on tax credits allows us to explore the level of need, and in which areas.
- Services, e.g. school meals, can then be planned and better targeted.

Top 10% by number of children supported by tax credits Areas

In these areas between 50-100% of resident children receive tax credits



No of Children supported through Tax credits compared to resident population 0-17 years

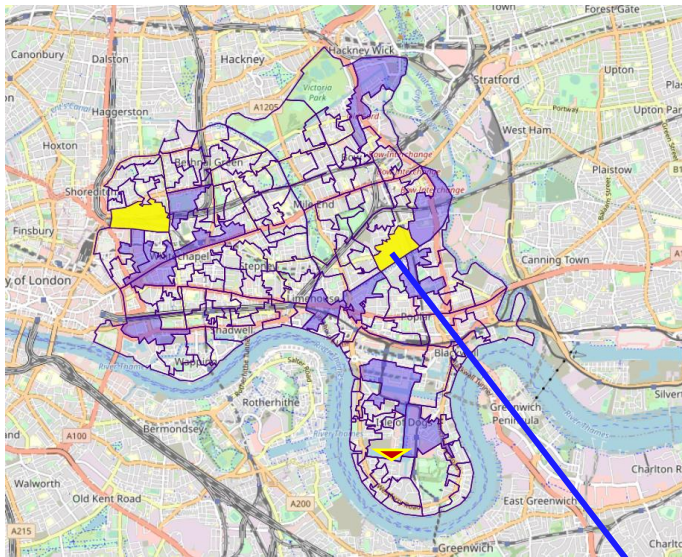




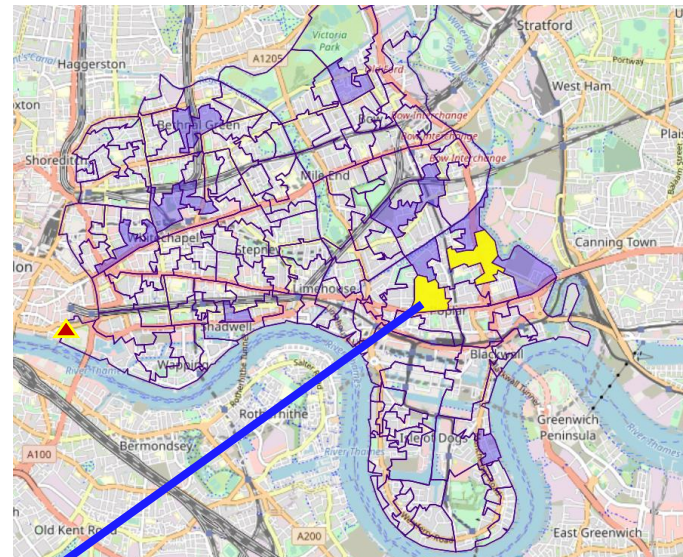
# Example: Employment & Crime in Tower Hamlets

Areas with highest crime rate (in area top 10%)

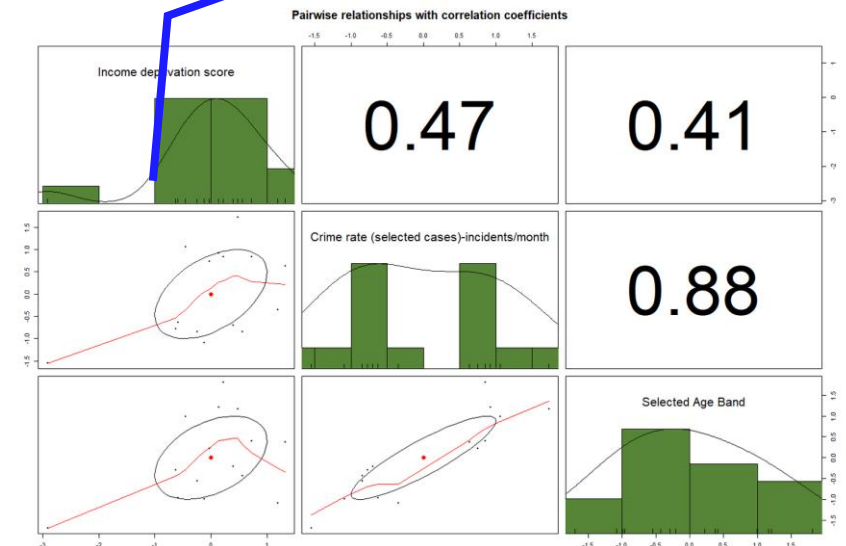


Areas with highest unemployment (in area top 10%)



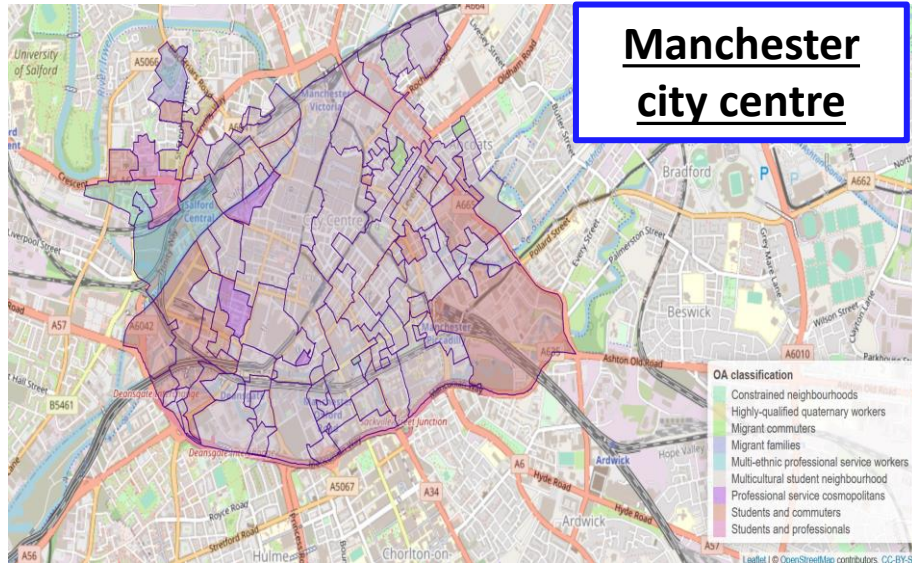

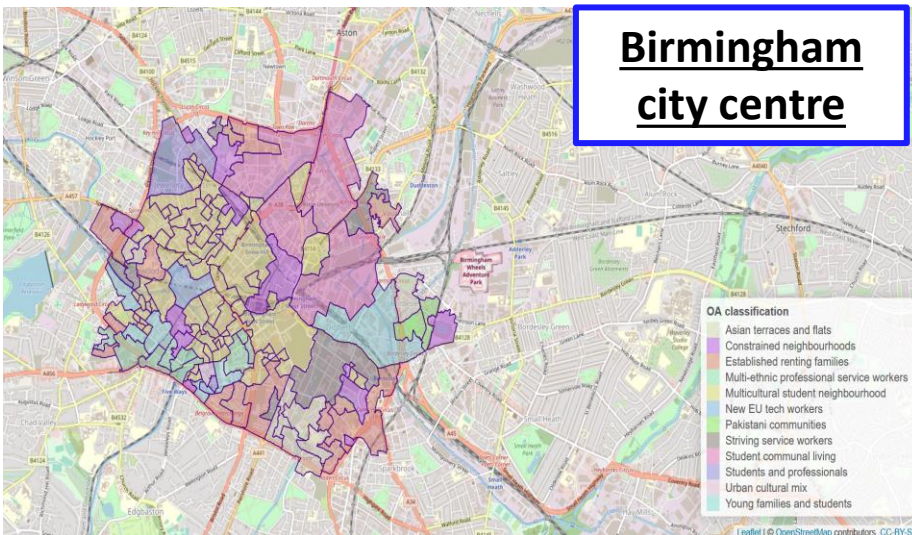
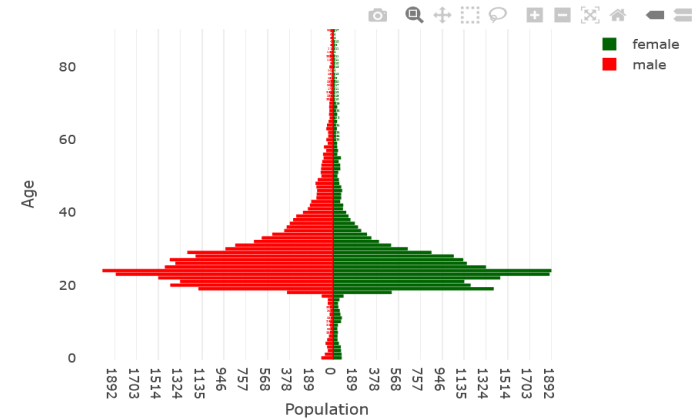

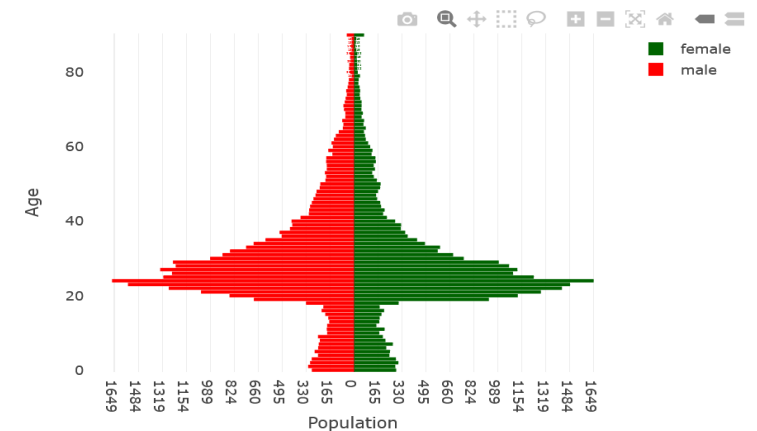

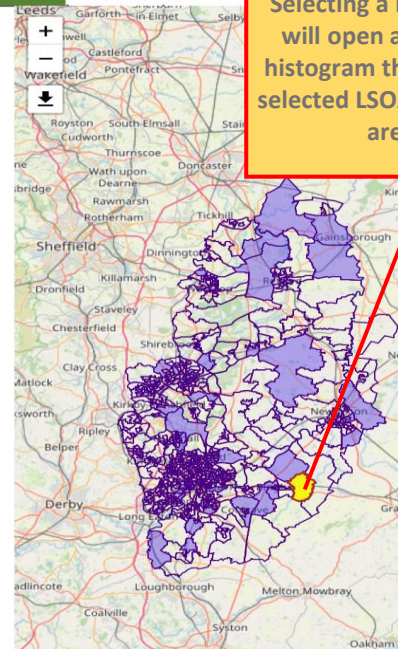

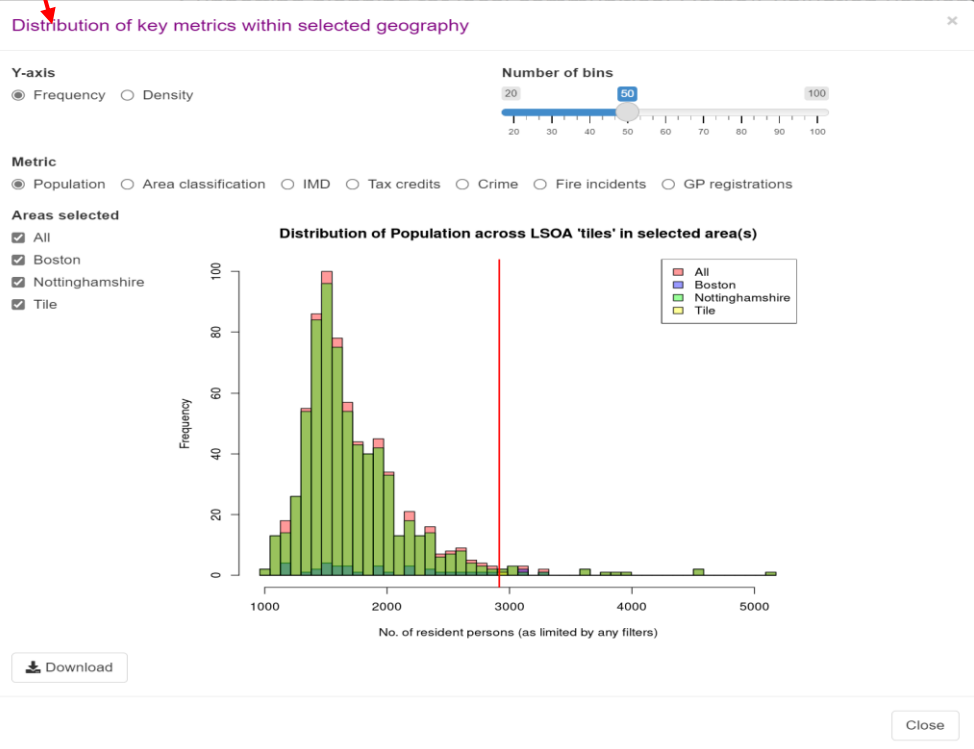

# Experience Using R

- Functionality in R is spread across the language and a vast range of packages that specialise in particular areas. These packages can be exceptionally powerful, and are well curated/maintained. And open source. They provide a solid basis on which to build.
- We made particular use of those packages that help manipulate data frames and other more complex list structures: to shape and join the available open source data into relevant and useful combinations.
- Mapping: the 'leaflet' package handles geographic information superbly!
- R Shiny provides the framework for organising the exploration and analysis work flow of the application organise the information.
- A key challenge in a project like this is deciding how much to build for yourself, and how to stitch together the functionality of ready built solutions! Not always straightforward
- All in all R is a fun language to work with (with the occasional surprise!)

# Summary

- We are excited about the potential of **Environs** to gain value and provide insights. What started as a proof of concept is turning into a commercial product. And we are continuing to develop it!
- Just as important, an enterprise can choose to maximise the utility of its own data by adding that in. So bespoke configurations are possible.
- The ability of R to combine and process data, do statistics and visualise the results, all under one roof, has definitely been a key enabler.
