- Farm raised meats, processed/packaged in an approved USDA facility & held on-site in a powered cold holding unit.
- Commercially prepackaged shelf stable foods and beverages (without ice).
- Commercially prepackaged ice cream and frozen yogurt novelties (no scooping or soft-serve).
- Hot beverages, shelf stable donuts, and pastries (cupcakes, bagels, cookies) – Commercially prepared, not Cottage.
- Popcorn, which is seasoned with salt, buttered, or sugared (kettle corn).
- Dry shelf stable foods, portioned onsite, (which must be cooked 1st to be consumed: pasta, beans, dry spices, coffee beans, tea leaves, **but not** blended ingredients such as spices or dry soup mixes).
- Food or eggs that meet the requirements of the [Colorado Cottage Food Act](#). (Submit training certificate, menu, labels, disclaimer)
- Food made & prepackaged in a commercial facility by the vendor or wholesaler & properly labeled for resale. (Submit label)
- Young Entrepreneur: Child run low-risk food sales, ie. Baked goods. (Submit proposed menu & age of child)
- Food preparation &/or service of unpackaged food that requires temperature control = **Must complete [Temporary Food Vendor Application](#)** for a temporary food vendor license through Teller County Health Department. (A fee may be charged.)
