

The new location is accessible to all - there are no steps to get into the facility and there is plenty of parking. In January, we will return to Old Country Buffet at Fair City Mall for the monthly KIT luncheons.

At the December luncheon, we will be collecting canned and packaged goods for Food For Others, a local food bank. The number of hungry families in our area continues to grow, so please bring along some items to help those in need.

Planning for next year's activities has already begun. The Retirees Association will host the 4th annual Information for Seniors Fair on Wednesday, May 21st, 10 AM – 2 PM. (This event will replace the KIT luncheon that would normally take place that day). As you know, numerous organizations attend our event to share information that might be of interest to seniors in general, and to our retirees in particular. Past participants have included County agencies (such as the Retirement Office and DHR's Benefits staff), private insurance providers, Fairfax County Credit Union, Everly Funeral Home, and Osher Lifelong Learning Institute, among others. Inova generously provides free health screenings and general information about common health conditions, such as diabetes and hypertension. We even have some retiree entrepreneurs selling their wares! Our goal is to make each year's event even better than the year before's. WELLNESS

The most exciting addition for 2014 is a Wellness Incentive Points Program for participants in the County's <u>self-insured plans</u>. The program will give retirees who elect to participate in one of the Cigna managed plans, the opportunity to earn points for engaging in certain wellness activities such as taking an on-line health assessment, completing annual preventive exams, participating in various optional lifestyle management programs (including weight management and tobacco cessation) and LiveWell sponsored events throughout the year. Each point earned is worth \$1.00, and participants can earn up to \$200 in wellness rewards annually. Look for more information in January 2014.

CIGNA

New insurance cards will be mailed in December to all CIGNA enrollees.

Nearly 1700 retirees receive health benefits from the county and were affected by the recent changes to CIGNA.

Keisha Lewis is the CIGNA representative and will have an office in DHR. Her telephone number is 703-324-2446.

Some changes to CIGNA benefits are:

- Free mail order prescriptions for most preventive generic medications.
- Davis Vision will cover eyeglasses purchases to each year instead of every two years.
- Davis Vision will increase frame allowance from \$130 to \$150.
- Wellness Incentive Points Program.


