# **Bryan Hill Appointed County Executive**

In November 2017, the Fairfax County Board of Supervisors appointed Bryan Hill as county executive, effective Jan. 2, 2018. Hill was the James City County, Va., administrator and clerk to its Board of Supervisors. He replaced Edward L. Long, who retired in September. Kirk Kincannon served as acting county executive in the interim.

Board of Supervisors Chairman Sharon Bulova noted Hill's impressive leadership, management, communications and budget experience, and expressed the Board's confidence that Hill will continue to build upon a foundation of excellence for both the workforce and county residents.

Hill had been with James City County since 2014, and he previously spent seven years with Beaufort County, S.C. as deputy county administrator.

At James City County, Hill was responsible for oversight of staff, major infrastructure projects, economic development, transportation initiatives and the development and implementation of the county's first strategic plan. He recently led the realignment of the county's debt portfolio, which resulted in AAA ratings from each of the three major bond rating agencies.



Hill also previously served as the vice chancellor for finance and operations at the University of South Carolina's Beaufort/Bluffton Campus, and as the director of finance for the University of Maryland's Office of Information and Technology as well as director of administration for the Department of Aerospace Engineering.

Hill is the recipient of an award for academic excellence from the American Association of Budget and Program Analysts, and while at the University of Maryland, he earned the A. James Clark School of Engineering Staff Award and a commendation from the Department of Aerospace Engineering at its 50th anniversary celebration.


He has a bachelor's degree in public administration from Alfred University and a master's degree in public administration from the University of Southern California. Hill will receive an annual salary of \$250,000.

# **New Medicare Cards start Mailing in April 2018**

Beginning April 2018, The Centers for Medicare & Medicaid Services (CMS) is removing Social Security Numbers (SSNs) from all Medicare cards and replacing it with a new Medicare Number. Each person with Medicare will get their own randomly-generated Medicare Number. The Medicare Number will be 11 characters long, contains numbers and uppercase letters, and will be unique to each person with Medicare. This change will help protect the identity of people with Medicare. Click here for a sample: CMS Medicare

#### **New Medicare ID Cards**

People with Medicare don't need to do anything to get their new card. CMS automatically will mail Medicare cards with the new Medicare Number to all Medicare recipients people between April 2018 and April 2019. According to the CMS website, cards for Delaware, District



of Columbia, Maryland, Pennsylvania, Virginia and West Virginia participants will be mailed out April – June 2018.

To make sure Medicare has your current address you can contact Social Security at ssa.gov/myaccount or 800.772.1213. TTY users can call 800.325.0778.

There will be no changes to Cigna/Cigna-HealthSpring issued ID cards. Customers should keep and continue to use their Cigna/Cigna-HealthSpring issued ID card as

they normally do.

#### **Please Note:**

This change means that FC Retirees who are Medicare participants will have to provide the FCG Benefits Office with copies of their new cards so that our records and those of Cigna and Kaiser can be updated to match CMS. The Benefits Office will send out postcard reminders quarterly over the next year to remind retirees to send in copies of their cards.

Please send a copy of your new card to the FCG Benefits Division, to the attention of Agnetta Palacios as soon as you receive it. This can be done by mail, fax or e-mailed to Agnetta.Palacios@fairfaxcounty.gov. The mailing address is 12000 Government Center Parkway, Suite 270, Fairfax, VA 22035 or fax to 703-802-8795. If you provide a phone number or e-mail address Agnetta will confirm the receipt of your new card.

#### We want to thank Sandy Benfit for the following:

This is a work history of my parents John & Bernice Hoffman written by their daughter who is also a retired Fairfax County government employee, Sandy Benfit, who many may remember as Sandy Jones.

My father, John Hoffman passed away on June 9, 2014 at the age of 89. He started his Fairfax County employment as a Surveyor for the Department of Public Works in 1969. Dad was a surveyor and party chief for many years under the direction of Elmer Thompson & Burt Sours. He made many friends who became like family to us over his working career. His entire County career remained in the Survey branch until retirement in 1990.

My mother, Bernice (Bernie) Hoffman passed away on September 16, 2017 at the age of 93. She started her career with the Cooperative Computer Center (CCC), now called Department of Information Technology (DIT) in the basement of the Old Post Office building in 1957. She worked there until she went on maternity leave with me in the fall of 1961. Back then she was able to pay in to her retirement while she was on maternity leave so she would have a job to return to. She stayed home with me and cared for me until I went into first grade. When she returned back to work in 1968, the County placed her in the Office of Finance (now the Department of Finance) at the Old Courthouse building in Fairfax. I remember her telling me that she watched the Massey Building being built. Going from farm land to the tallest building in Fairfax! The Massey building opened in 1971 and many of the

County Government agencies moved there as well as mom. She started a new department in Finance called FAMIS (Financial Accounting Management Information System) and remained there until her retirement in January 1989.

Mom and Dad told me that Fairfax County was the best place to work because of the many jobs that the Government had to offer and it had the best benefits. They encouraged me and mom got me to apply for a job in Finance. I got my first real job working for Wayne Boles in the Office of Finance in 1981. I left Finance in 1988 to pursue a career in Purchasing & Supply Management (now Department of Procurement & Materials Management) where I stayed until I retired in 2012.

Along the way, I encouraged my sister Cathy Palmateer to join the County family. She started working in the Office of Assessments (now Department of Tax Administration) in 1983 and remained there until her retirement in 2012. Together Cathy & I encouraged other family members to join in on the family work tradition. Currently we have two nieces, a nephew, a great niece, a great nephew, a cousin and my husband, Joseph Benfit who continues to work for Fairfax County Government.
