A Trip to the Emerald Isle, by Bobbie Deegan

My husband, Charlie, and I visited Ireland this summer. It was our first visit to the homeland of his grandfather, and we had a wonderful introduction to the Emerald Isle.

We stayed in Belfast, in Northern Ireland, and Dublin, in the Republic of Ireland. If you



weren't sure which part of Ireland was which when you first arrived, you were soon set straight! Across the street from our hotel in Belfast was a wall-sized painting of a Dutchman, William of Orange, who brought Protestant rule to Britain in partnership with his wife, Mary from 1689 until 1702. (The College of William and Mary, in the colony of Virginia, was chartered by them and named in their honor).

In Dublin, on the other hand, they were commemorating the 100th anniversary of the Easter Rising, when armed Irish men and women seized key locations in Dublin and tried to drive the British out and establish an independent Irish Republic. They fought gallantly, but were outnumbered and out-equipped by the Brits, and Irish leader Patrick Pearse agreed to an unconditional surrender to prevent the deaths of additional non-combatants.

I wasn't there long enough to see many of the historic sites, but I now have a far better understanding of the English-Irish antipathy. It will be interesting to see how Brexit plays out in Ireland. Since Northern Ireland will be outside the EU and the Republic of Ireland will remain in the EU, there is talk about building a wall between the two to control immigration. It appears they have a way to go yet, but at least both sides are enjoying the peace.

It wasn't all politics.

In Belfast, we visited the museum where the Titanic was built. I confess I am more interested in the human side of the Titanic than I was in the technical side of shipbuilding (although the amount of detail in the architectural drawings was eye-opening). I was surprised to learn that even the tenders to the ship were class-oriented. Third-class passengers had a separate tender from that for first- and second–class passengers, and second-class passengers were in "the back of the boat" for their tender. Also in Belfast, we took a bus tour to the Giant's Causeway in County Antrim, Northern Ireland. The Giant's Causeway consists of 40,000 interlocking hexagonal basalt columns that were the result of a volcanic eruption 50-60 million years ago.

In Dublin, we took a tour of Trinity College and traveled to the coast to see the Cliffs of Moher, Ireland's most visited natural attraction. The cliffs stretch five miles along the Atlantic coast of County Clare. We also visited the Guinness Storehouse, where we learned the correct way to pour a pint, and toured the Bushmills Distillery, where they used to make whiskey. And of course we had some Irish stew in a local pub and watched some Irish dancing! It was a wonderful trip.

County Health Benefits: Did you know?

Did you know that Fairfax County Government has a Duplicate Billing/Overpayment Award Program? This program was designed by the Benefits Division to encourage employees and retirees to review their medical bills carefully. If you are a participant in one of the self-

insured Cigna plans and you find an error of more than \$50 in your medical bills, you could be entitled to receive a financial reward of half the amount saved, up to \$1,000. This extra layer of oversight helps to keep claims cost down for everyone. If you believe you have found an error in a bill you received for medical treatment contact the Department of Human Resources – Benefits Division at (703) 324-3311.

The Historic Records Center (HRC) is located in Suite 1600 of the Fairfax Historic Courthouse (4000 Chain Bridge Road). We are open Monday through Friday, 8:00 am – 4:00 pm. The Historic Records Center houses court records dating back to the formation of Fairfax County in 1742 up through the early 1900s.

Among our holdings, you may find marriage information/licenses; birth and death information; probate records and deeds; court order books; assorted military records relating to the Revolution, War of 1812, Civil War, and Southern Claims; and tax records.

We are open to the public and invite you to visit! We serve genealogists, historians, and citizens interested in local history.

HRC Staff offer tours of the Historic 1799 Courthouse and Records Showroom on Fridays at 11:00 am and 3:00 pm. No reservation needed – meet under the arcade of the 1799 Courthouse (facing the cannons).
