They help isolated individuals to "age in place" by delivering meals with *Meals on Wheels*, doing grocery shopping, running errands, driving them to medical appointments and providing social companionship. Volunteers also help at senior centers and adult day health care centers as front

desk or activity assistants, and/or by sharing their own talents and skills with

participants through weekly classes and activities. Volunteers with gentle pets can also be a part of *Pets on Wheels*, where their furry companions brighten the lives of long-term care residents. 
