The main activity that has sustained me in these past years has been joining the League of Women Voters and working to assist the Prince William County Election Office. I have enjoyed bright and committed women and men who volunteer their skills to register new voters in high schools, at citizenship ceremonies and throughout the community. This has brought me the opportunity to meet inspiring public figures, authors, and academics who have advanced my civic education. ## **Recipe for Sauerkraut Salad**

I got this recipe from my mother-in-law "back in the day" when we both cooked! It is so easy to make, and it is so good!

2 pounds Double H sauerkraut [the one in the bag], drained
1 cup sugar
1 cup celery, chopped
1/2 cup green pepper, chopped
1/2 cup onion, chopped

1/2 cup salad oil1/4 cup vinegarCelery seed, to tasteSweet red pimento, for color (optional)

Put sauerkraut in a colander, rinse in cold water and drain thoroughly. Move it to a mixing bowl and add remaining ingredients. Mix well. Refrigerate overnight.


