Health Care Benefits

The Fairfax County Government 2021 Open Enrollment period is right around the corner, and with our new contracts in place, there will be some changes in our plan offerings. In keeping with our longterm strategy, the Cigna Co-Pay plan will



be closing to all participants on December 31, 2020. All participants in the Co-Pay plan will be automatically mapped to the Cigna 90% Co-Insurance plan, with the option to elect coverage under one of the other plans offered.

Cigna successfully bid on our contract for the administrator of our self-insured plans in the recent RFP process. They will continue to administer our self-insured Medical and Prescription Drug plans, as well as the Group Medicare Part D, EGWP

plan for Medicare eligible participants as well as one of our new Medicare Advantage Plans. The county also awarded a contract to United Health Care for a second Medicare Advantage Plan.

Plan participants under age 65 will have plan options of the Cigna 90% Co-Insurance Plan, the Cigna 80% Co-Insurance Plan, the MyChoice CDHP and the Kaiser HMO.

Medicare-eligible participants will have five plan options: either of the two Cigna Co-Insurance plans that are secondary coverage to Medicare, the Cigna Medicare Advantage Plan, the United Health Care Medicare Advantage Plan, or the Kaiser Medicare Advantage Plan. Please note that both the Cigna and United Health Care Medicare Advantage Plans are national plans and cover services anywhere in the United States.

The 2021 Open Enrollment Period for retirees will run from **November 2nd through November 30th, 2020**, with all elections and changes taking effect on January 1st, 2021. With the termination of the Co-Pay plan and the addition of the two Medicare Advantage plans, the Benefits Team will be hosting additional planning meetings (see below) prior to the beginning of the Open Enrollment election period. Each workshop will focus on one specific plan, to offer participants a more thorough understanding of the benefits offered in each plan.

We will continue with our usual open-enrollment style presentations in November, but they will be done virtually because the current health crisis does not allow for safely holding in-person workshops.

2021 Retiree Pre-Open Enrollment Plan-Specific, Virtual Education

Things are a little different this year. The Benefits Team is changing, too. We are redefining Open Enrollment and moving to a virtual format due to the current health crisis. But that doesn't mean we won't be here for you!

Before Open Enrollment kicks off on November 2nd, our Vendor Partners will be offering plan-specific workshops. Attend and discover more about each plan, including our new Medicare Advantage Plans, from the experts before attending a general meeting in November.

DHR will soon be sending out postcards, notices and packets on how to access these sessions.

Election Officers Needed for the November 2020 Election.

The Fairfax County Office of Elections needs election officers to assist voters on election day, Tuesday, November 3, 2020.

New election officer training classes will begin online in September for the November General Election.

Fairfax County is the largest voting jurisdiction in Virginia, with 243 precincts countywide. It takes thousands of enthusiastic and trained election officers to ensure that we have efficient and well-run elections. In particular, bilingual Vietnamese or Korean speakers are needed in Annandale, Centreville, and Falls Church. Compensation begins at \$175. If you are a registered Virginia voter, consider applying today!

Vote on November 3rd

In Virginia, there are THREE options for voting:

Vote in person on Election Day at your assigned precinct, Vote absentee by mail, or Vote absentee in person at any satellite.



Vote In Person: Please note that Virginia law requires all voters to provide an acceptable form of identification at the polls. For more information on in-person voting at your assigned precinct, go to vote on election day.

Vote Absentee: There are two ways to vote absentee in Virginia: in person and by mail. In 2020, the state legislature passed a law permitting any registered voter to vote by absentee ballot in any election in which he is qualified to vote and removed the list of statutory reasons under which a person may be entitled to vote by absentee ballot.

Bottom line - You can request an **absentee mail-in ballot** or **vote absentee inperson** without an excuse or reason.

Absentee Mail-in Ballots for the November 3rd General Election will be mailed to voters beginning September 18th. With unprecedented demand expected this year, apply now to be sure you receive your ballot and have your voted ballot received at the Office of Elections in time to count.

- * Sept 18: Early voting/absentee in-person voting begins at Government Center Pkwy, Fairfax, VA. There will be signs directing you to the location.
- * Oct 13: Voter Registration Deadline (In person/By mail 5 pm) (online: 11:59 pm)
 - * Oct. 14 30 In-person absentee voting at 14 satellite locations.
- * Oct. 17, 24 and 31, In-person absentee voting on Saturday's at 14 satellite locations and the Government Center, 9 am to 5 pm

For the locations, times and more information on satellite in person voting go to the Electoral Board Absentee Voting Website.

- * Oct 23: Deadline to apply for Absentee Ballot by mail, fax, online: 5:00 pm
- * Oct 31: Final day to vote absentee (early/in-person) 5:00 pm
- * Nov 3: Election day 243 precincts will be open from 6 am to 7 pm
- * Nov 6: Deadline to return absentee ballot:12 noon, they must be postmarked by Nov 3, 2020.

Confirm your voter registration and polling location before the October 13, 2020 deadline. Due to the pandemic, some polling locations may have changed. For the latest voting information in Fairfax County, please visit: Fairfax County elections.

All satellite and precinct locations will be following the latest CDC guidelines in PPE and social distancing requirements.

End of an Era and an Icon in Fairfax City



The Massey Building – once the tallest building in Fairfax City – is now being demolished. For nearly half a century, it stood across from the county Courthouse. From 1969-92, it was the seat of Fairfax County Government, until the current county Government Center opened in Fair Oaks. It then housed the administrative offices of the county's Fire and Police departments.

But since the Massey Building's abundance of asbestos made it a health hazard to those working inside it – and the fire and police headquarters moved to a safe and modern home in a new building off Monument Drive – this 13-story structure is coming down.

Summer Shred Event – New Location

Our last Shred Event was very successful so we have decided to hold another in Sterling on **Saturday**, **August 29**. Join us from **8-11am at 21430 Cedar Drive**, **Sterling**, **VA** and bring your personal documents for shredding.

IMPORTANT: This is a first come, first served event and is open to the community. Once the truck is filled to capacity, the event will come to an end. To adhere to health and safety guidelines, please follow these instructions upon arrival.

- 1. Enter the parking lot and follow traffic instructions to the TrueShred truck.
- 2. When you arrive at the front of the line, we ask that you remain in your vehicle.
- 3. Open your trunk and the TrueShred attendant will remove your items to shred.
- 4. The attendant will return any plastic bags or large boxes to your trunk.
- 5. If you must exit your vehicle, please maintain a 6-foot distance and wear a face mask.

Thank you for helping us keep our community safe. We look forward to seeing you. Note: Because the event is limited to a 3-hour window, we are allowing no more than 3 boxes per person (approximate box size is 10"H x 18"W). Plastic bags, bottles, cans, cannot be shredded. Please ensure these items are not mixed in with your paper items.
