A few reminders from the DHR- Benefits Team....

- The best way to keep up with retiree benefit news and resources is to visit our new Retiree Benefits Page on the public site: www.fairfaxcounty.gov/hr/department-human-resources-retiree-benefits
- If you enrolled in a new medical plan during Open Enrollment, you will receive a new medical card by mail.
- Retirees and dependents who maintained coverage in one of the following medical plans will receive new cards:
 - o Cigna MyChoice CDHP Plan
 - o Cigna 80% Co-Insurance Plan
 - o UnitedHealthcare Group Medicare Advantage Plan

Participants in the Cigna 90% Co-Insurance Plan or enrolled with a Kaiser Permanente Plan can continue to use the same benefit cards.

- Delta Dental and EyeMed vision will not reissue cards. Should you need a replacement card, you will be able to print card through your online accounts:
 - o Delta Dental plan: www.deltadentalva.com
 - o EyeMed Vision: www.eyemed.com
- Annually, Cigna updates the Part D formularies based on Medicare requirements. Changes are provided in the full formulary that is mailed with renewal kits. Additionally, members also may receive a letter from Cigna Rx Medicare Part D Prescription plan. Have you heard about the new beneficiary designation process?

As of January 4, 2021, Fairfax County Government retirees who have maintained enrollment in life insurance will be able to use the new online system to name or update their life insurance beneficiaries.

Ready Enroll is Fairfax County Government's new online beneficiary designation system. It allows you to update your life insurance beneficiaries from anywhere, at any time. Leave no doubt about who will receive this important benefit.

Note: retirees will not be able to view or confirm current beneficiary designations made previously by paper form unless the information has been updated in the new system. If you have completed a paper beneficiary form in the past, Fairfax County Government will continue to refer to this document for beneficiary designation confirmation until you have updated your designations in the new Ready Enroll system.

Are you ready to get started?

- Visit the online portal at https://standard.benselect.com/
- Your username is your Social Security Number, without the dashes.
- Upon first login, your PIN is the last four digits of your Social Security Number followed by the last 2 digits of your birth year. You then will be prompted to change your PIN.

Example: If your Social Security Number is 123-45-6789 and you were born in 1970, your username would be 123456789 and your initial PIN would be 678970.

The Social Security Administration will never threaten, scare, or pressure you to take an immediate action.

If you receive a call, text, or email that...



- Threatens to suspend your Social Security number, even if they have part or all of your Social Security number
- Warns of **arrest of legal action**
- Demands or requests immediate payment
- Requires payment by gift card, prepaid debit card, internet currency, or by mailing cash
- Pressures you for **personal information**
- Requests secrecy
- Threatens to seize your bank account
- Promises to increase your Social Security benefit
- Tries to gain your trust by providing fake "documentation," false "evidence," or the name of a real government official

...it is a SCAM!

Do not give scammers money or personal information – Ignore Them!
