What Happened to Davis Vision?

One of the most frequent calls the Benefits Division receives from retirees is regarding our vision care plan provider and the switch from Davis Vision to EyeMed. Remember, effective January 1, 2020, the vision provider for Fairfax County Government employees, retirees, and their covered dependents became EyeMed. The announcement of this change and vendor information was included in open enrollment materials mailed to addresses of record and posted online beginning in the fall of 2019. Enrollment in the vision care program is automatic when enrolled in a county-sponsored medical plan. Correction

In the previous edition of Hot Flashes, it was noted that participants in the Cigna 80% Co-insurance Plan would receive new cards for plan year 2022. More specifically, participants in the Cigna 80% Co-insurance Plan without Medicare will receive new cards for plan year 2022. Because the only changes made to the Cigna 80% Co-insurance Plan were to the pharmacy benefit, participants with Medicare using the Cigna RX Part D Prescription Plan do not need new cards to access their medical services. Therefore, Fairfax County Government retirees and their covered family enrolled in the Cigna 80% Co-insurance Plan with Medicare will not receive new cards for plan year 2022.

The Benefits Division: How Can We Help You?

The Benefits Division in the Department of Human Resources administers the health and other benefits for employees and retirees of Fairfax County Government. Our team oversees benefit program administration for both active employees and retirees. We follow all county and federal policies and procedures to ensure the privacy and accuracy of participants' information.

Retiree programs administered by the Benefits Division include:

- Medical
- Vision
- Dental
- Life Insurance
- Deferred Compensation

Our team can assist retirees with the following concerns:

- Ensuring your address is up-to-date for benefits communications and with our vendor partners.
- Verifying benefit enrollment for you or your covered dependents
- Making benefit changes due to a qualifying event
- Answering premium and benefit deduction inquiries
- Escalating service and claims concerns after connecting with vendor customer service

If you or a family member needs assistance with one of our county-sponsored benefit plans, our Know Who to Call Document can be found on the Retiree Benefits Page on the public website along with other important information regarding retiree benefits.

It is important to note that the Benefits Division cannot share personal healthcare information or enrollment details with anyone other than the retiree and plan subscriber. To protect participants' privacy, the Benefits Division will not provide personal information with any third party. We will only share publicly-available plan information.

A retiree must provide written permission in advance before any details can be shared with a family member. Any changes requested by someone other than the retiree will only be granted after review, and approval of, a legal Power of Attorney or other legal document granting that person the right to act on the participant's behalf. These documents must be submitted to the Benefits Division. Privacy guidelines apply in all circumstances, even if both participants are current or former county employees.

FY2023 Fairfax County Advertised Budget

The Fairfax County Executive presented the FY2023 Advertised Budget to the Board of Supervisors on February 22nd. After numerous steps, including public hearings, the final approval will be on May 10th.

It was created to account for the cost of other post-employment benefits (OPEBs), including health care, life insurance, and other non-pension benefits offered to retirees, such as the County's retiree health benefit subsidy. Covid-19 Tests

Each household in the U.S. is entitled to four **free COVID-19** at-home tests, shipped directly to your home at no cost. Order your tests now so you have them when you need them. For more information and to order, go to:



Covid Test Kits

The tests are rapid antigen "at-home" or "self" tests -not PCR tests which require a lab "drop-off." These test kits can be taken anywhere and provide results in 15 minutes.

Volunteer Advocates Needed!

Many residents in long-term care (LTC) facilities can sometimes feel alone, isolated, and powerless. As a mandated program under the Older Americans Act, the Northern Virginia Long-Term Care Ombudsman Program (NVLTCOP) is often called on to assist residents and consumers to advocate for their rights to ensure quality of care and quality of life. NVLTCOP serves Arlington County, City of Alexandria, Fairfax County, and Loudoun County. The NVLTCOP needs volunteers who can advocate for the rights of residents in LTC facilities and help them with concerns that they are unable to resolve alone. We seek those who are willing to complete a comprehensive initial three-day training, commit to a minimum one year of service, and who can devote at least four hours per week assisting residents at assigned facilities close to home or work.

Office of Elections

Vietnamese and Korean Speakers Needed as Election Officers for the 2022 Elections

The Fairfax County Office of Elections needs additional bilingual election officers to assist voters in the June primary and November general elections.

Specifically, registered Virginia voters who speak Vietnamese and English fluently or Korean and English fluently are needed to serve in the areas of Annandale, Centreville, Chantilly, and Falls Church.

You will perform all regular election officer duties, including assisting most voters in English, but will be assigned to precincts with a significant number of voters who may primarily speak Vietnamese or Korean. To serve as a designated bilingual election officer, you must also complete a short oral language skills assessment.

Fairfax County is the largest voting jurisdiction in Virginia with 247 precincts countywide. It takes thousands of enthusiastic and trained election officers to ensure that we have efficient and well-run elections. Compensation begins at \$175 and training is provided online for new officers.



Finally... Food for Thought

During World War II, fighter planes would come back from battle with bullet holes. The Allies found the areas that were most commonly hit by enemy fire. They sought to strengthen the most commonly damaged parts of the planes to reduce the number that was shot down.



A mathematician, Abraham Wald, pointed out that perhaps there was another way to look at the data. Perhaps the reason certain areas of the planes weren't covered in bullet holes was that planes that were shot in those areas did not return. This insight led to the amour being re-enforced on the parts of the plane where there were no bullet holes.

The story behind the data is arguably more important than the data itself. Or more precisely, the reason behind why we are missing certain pieces of data may be more meaningful than the data we have.
