### General Announcements:

Sign-in at the start area tent. Sign-in opens an hour before and closes 10 minutes before assigned start time. Failing to sign in for the circuit race stage may result in fines per USAC 8A5(L).

**Podium:** The Women Pro/1/2 GC Leader's Jersey for Stage 2 Sahuarita Road Race will be awarded with the first wave podiums at approximately 9:50 AM.

**Parking Reminder:** Only Pro Race riders will be permitted in the designated “Pro Team Parking” area. Others are to use the back lot. See Page 19 of the Technical Guide.

**BE SELF SUFFICIENT!** There is no rider water available at the Oro Valley – Naranja Park venue.

**Rider Staging:** Pre-staging is on the right side of the road as you exit Naranja Park, behind the staging for race vehicles. The entrance into Naranja Park will be closed 5 minutes prior to the race start. Each field will move forward toward the entrance and will stage in the LEFT lane.
