Eligibility Requirements

- Primary diagnosis of serious mental illness
- Age 18 years or older
- Income below 150 percent of the federal poverty level
- Able to live in a community with program services
- Actively receiving Medicaid or are Medicaid-eligible if discharged from a state hospital

Eligibility Criteria

Long Term Hospitalization: 3 or more cumulative or consecutive years in an inpatient psychiatric hospital during the 5 years prior to enrollment; or

Jail Diversion: 2 or more psychiatric crises) and 4 or more discharges from correctional facilities during the 3 years prior to enrollment; or

ED Diversion: 2 or more psychiatric crises) and 15 or more total ED visits during the 3 years prior to enrollment
