By signing this agreement, the **Adopter** agrees that if he or she decides to sell or otherwise transfer the ownership of the horse in the future that **NRSHR** will be notified and given first refusal rights to re-acquire the horse for the amount of the adoption fee (if any) paid for the horse. The **NRSHR** has seven (7) days in which to exercise the right of first refusal from the date of receipt of notification by the **Adopter**. If the **NRSHR** opts not to exercise the right of first refusal, the **Adopter** shall provide the **NRSHR** with the name, address and telephone number of the owner to which the horse may be transferred so that the **NRSHR** may update its records and monitor the whereabouts, health and safety of the horse

It is further agreed that any subsequent owner/adopter will complete a copy of this Agreement, and the subsequent owner/adopter shall be bound by the terms thereof. **NRSHR** reserves the right of inspection of the horse and the living conditions with verbal notice throughout the horse's lifetime. If it is determined by **NRSHR** that said horse is in unsafe conditions or not being cared for properly, then **NRSHR** reserves the right to seize the horse.

If the SPCA or any Humane Department is called on the **Adopter** for a legitimate claim, **NRSHR** may recover the said horse.

Finally, the undersigned solemnly swears and agrees that this horse will only be transferred privately and will not be resold at any type of auction, or to a horse broker, feedlot or slaughter destination. In the event the undersigned fails to comply with the terms of this Application, **NRSHR** reserves the right to commence legal proceedings to recover the horse and the undersigned shall be liable for all costs including damages to **NRSHR**.
