**COPE 69081-OP 2 hr – Melton & Thomas**

**State of Therapeutics - Part I**

The Melton-Thomas team discuss some of the common and not-so-common disorders often seen in the primary care optometric practice. Current information and recommendations are discussed regarding approved drugs and treatment modalities as well as off-label use of drugs.
