WHEREAS, The Detachment of Arizona, Sons of The American Legion is structurally modeled after The American Legion, Department of Arizona with regard to officers, where possible, and

WHEREAS, The Department of Arizona, The American Legion does not have a separately elected Executive Committee, and

WHEREAS. The accepted purpose of electing a separate Detachment Executive Committee was to provide visibility and experience to potential future leadership candidates, and

WHEREAS, The Detachment Executive Committee members do not have any responsibility to report to the Detachment of Arizona during regular conventions or conferences, which would allow greater visibility and a chance to show leadership qualities, and

WHEREAS, Committees and commissions have a responsibility to accomplish goals and report their activities to the Detachment of Arizona at all convened meetings, and

WHEREAS, Being the chairman on a committee or commission would provide the visibility and show leadership qualities we seek for higher office, therefore, be it

RESOLVED, By the Detachment of Arizona, meeting at the Detachment Executive Committee meeting in Oro Valley, Arizona on November 5, 2022 that the Detachment Constitution for the Detachment of Arizona be updated to remove references made to Executive Committee Members At-Large in Article III, Section 1, Article III, Section 2, Article V, Section 1, and the complete removal of Article VII, Section 4, and, be it further

Title: Sons of The American Legion Detachment of Arizona Adjutant Expansion of Term for Continuity. Origin: Arizona resolution by: AZSAL Member Dennis Pittman (SQ 140)

WHEREAS, For the continuity of Detachment, the role of the Detachment Adjutant should span more than just one Legion calendar year as by mid-year an adjutant is already working on the following years calendar and events; and

WHEREAS, a good Adjutant is constantly working on improvements to the method and manner that the Detachment operates under; and

WHEREAS, many of the planned improvements take over a year to develop and then to implement; and

WHEREAS, the adjutant is heavily involved in the training and informing newly elected officers as to the current state of the Detachment, having been in place previously would greatly assist the new officers in as seamless as possible transition from the previous administration to the new; and

WHEREAS, the adjutant's job is not a step into and turn key position, it takes a large amount of man hours and training to become a good adjutant; and

WHEREAS, it is not out of expectation to give the adjutant some security that the hours spent developing the office for the betterment of Detachment are not spent in vain only to be abruptly stopped the following year; and

WHEREAS, the 2023 National Post Adjutants manual states "Many posts retain a good adjutant in office over a period of years as opposed to a one-year position." And many Departments, Detachments and our National organization retain Adjutants for multi-year terms; and

WHEREAS, All the pillars of The American Legion align with the purpose of an effective Adjutant and the mission of the various programs which are supported by the Detachment of Arizona; now, therefore, be it

RESOLVED, By the Members of the Sons of The American Legion Detachment of Arizona in regular meeting assembled in Tucson, Arizona, *Constitution Article V, Section 2*: striking the words "Detachment Adjutant".

Adding Constitution Article V, Section 2a, reading "The position of Detachment Adjutant is recommended and appointed by the Detachment executive committee as needed to a 5-year term of service in the position with renewal as per the Detachment Executive Committees discretion. The Adjutant corps consist of one (1) Adjutant and up to two (2) assistant Adjutants, but no less than one (1) assistant Adjutant is suggested be serving at any time. Assistant Adjutants serve in 1-year terms or remaining thereof, with renewal as per the Detachment Executive Committees discretion. Assistant adjutants assist the Adjutant as needed and are in training for future role as Adjutant. The sitting Adjutant with approval of the Detachment

Executive Committee, is allowed to pick the main assistant adjutant from the assistant adjutants appointed by the Detachment Executive Committee and has voice in assistant adjutant appointments by the Detachment Executive Committee." therefore be it finally

RESOLVED, hereby authorizing the additional change to the *Detachment Bylaws*, *By Laws Article I, Section 3*: adding before appointment sentence "The Detachment Adjutant is ex-officio to all Committees operating under the Detachment Organization". In appointment sentence striking the word "Commander", replacing with "Detachment Executive Committee".
